EASEMENT

of Helen Gust Young, A Single Woman, Grantor  
Magna, County of Salt Lake, State of Utah hereby  
grant and convey to the State Road Commission of Utah, Grantee,  
for the sum of Two Hundred and Twenty-four and no/100ths Dollars  
an easement over the following described premises situated upon the  
grantors land in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 32, T. 1 S., R. 2 W., S.L.M.  
in Salt Lake County, Utah, for the purpose of  
Constructing thereon a channel change for an irrigation facility  
and appurtenant parts thereof:

Two tracts of land 10.0 ft. wide adjoining easterly the easterly right of way line  
of highway known as Project No. 0135. Said tracts of land are contained within two  
side lines parallel to and at distances of 5.0 ft. easterly and 5.0 ft. westerly from  
the following described center line:

Beginning at the intersection of the south boundary line of the grantors land and  
said center line, which point is 1105.5 ft. south and approximately 72 ft. east from the  
N $\frac{1}{4}$  corner of said Section 32; thence N. 0° 12' W. 14 ft., more or less, to a northerly  
boundary line of said grantors land.

ALSO:

Beginning at the intersection of a southerly boundary line of the grantors land  
and said center line which point is 733.99 ft. south and approximately 73 ft. east  
from the N $\frac{1}{4}$  corner of said Section 32; thence N. 0° 12' W. 582.2 ft.

The above described tracts of land contain 0.14 acre, more or less.

After said irrigation facility is constructed on above described premises at the  
expense of Grantee, said Grantee is thereafter relieved of any further claim or demand  
for costs, damages or maintenance charges which may accrue against said irrigation  
facility or appurtenant parts thereof.
