Declaration of Restrictive Covenants

This DECLARATION OF RESTRICTIVE COVENANTS (this "Declaration") is made and entered into effective July 15 2010 by Bank of American Fork ("BAF"); Ledges Canyon Rim, LLC, a Utah limited liability company, Ledges Flint Rock, LLC, a Utah limited liability company, and Snow Canyon Golf Partners, LLC, a Utah limited liability company (collectively "Ledges Entities"); and JENCO, LC, a Utah limited liability company, Dean Gardner Investment, LC, a Utah limited liability company, and F.M. Snow Properties, LLC, a Utah limited liability company (collectively the "Land Owners"). Each of the above may hereinafter be referred to as "Party," and all collectively as "Parties."

RECITALS:

A. The Parties and others entered into an Amended and Restated Loan Termination and Settlement Agreement (the "Agreement") effective March 31, 2010, whereby, among other things, that certain loan made by BAF encumbering the real property which is the subject of this Declaration was terminated.

B. Pursuant to the Agreement, BAF has foreclosed trust deeds and thereby obtained fee title to all of the property described on the attached Exhibit A ("Lots Property"), which is incorporated into this Declaration by this reference. The Lots Property consists of eighty-six residential lots.

C. Pursuant to the Agreement, BAF agreed to release its mortgage lien from all of the property described on the attached Exhibit B ("Golf Course Property"), which is incorporated into this Declaration by this reference, and which Golf Course Property would thereupon be conveyed to Land Owners.

AGREEMENT:

In exchange for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the Parties agree as follows:

1. **Restriction.** With respect to any portion or all of the Golf Course Property and related facilities or other related private amenities now owned or controlled by any of the Parties for the use and benefit of the lots within the current "Ledges" project (or other subsequent project which includes any portion of the current Golf Course Property) located west of SR-18, the Parties will not adopt, propose, implement or observe, or permit the implementation or

observation of, any practices that discriminate between the membership rights, privileges and access, granted to the owners of lots located west of SR-18 and those granted to the owners of the Lots Property located west of SR-18. With respect to any portion or all of the Golf Course Property and related facilities or other related private amenities now owned or controlled by any of the Parties for the use and benefit of lots within the current "Ledges" project (or other subsequent project which includes any portion of the current Golf Course Property) located east of SR-18, the Parties will not adopt, propose, implement or observe, or permit the implementation or observation of, any practices that discriminate between the membership rights, privileges and access, granted to the owners of lots located east of SR-18 and those granted to the owners of the Lots Property located east of SR-18. The exercise of such membership rights, privileges and access by the Lots Property owners will, however, be subject to the Lots Property owners complying with whatever membership agreements, rules, regulations, standards, conditions or obligations as are then imposed upon other lot owners on a nondiscriminatory basis.

2. **Changes to Golf Course.** The Parties acknowledge that in the future (i) the Ledges golf course may be converted to a private club, in which case use of the Ledges golf course may be restricted to members of the club; however, none of the owners of the Lots Property will be discriminatorily refused admission to the club; (ii) portions of the land in the Ledges project area may be developed for commercial or residential uses that are different than the uses contemplated for the Lots Property and similar subdivision lots and thus may be entitled to different rights, privileges and opportunities; (iii) some real property contemplated for inclusion in the Ledges project may be separated into, and developed as a part of, one or more other projects with separate rights, privileges and opportunities; and (iv) the layout or configuration of the Golf Course Property may be changed which could result in a change in the legal description of the golf course and Golf Course Property. In the event any of the foregoing events occurs, the owners of the Golf Course shall be entitled to execute and record in the office of the Washington County Recorder such amendments to this Declaration as they shall deem necessary to reflect and document these events. Such amendments shall be recorded only on the Golf Course Property, shall not require the signature of the current or any subsequent owner(s) of the Lots Property, and shall be binding on the current and any subsequent owner(s) of the Lots Property without the approval of, or consent or other action by, the current or any subsequent owner(s) of the Lots Property. Notwithstanding the foregoing, no amendments to this Declaration shall have the legal effect of removing the non-discriminatory restrictions set forth in Sections 1 and 2 of this Declaration without compliance with the provisions regarding amendment in Section 7 below.

3. **Duration.** Except as expressly otherwise provided herein, the rights and restrictions specified herein shall be perpetual in duration.

4. **Not a Public Dedication.** Nothing contained in this Declaration shall be deemed to be a gift or dedication of any portion of any of the properties described herein to or for the general public or for any public purposes whatsoever, it being the parties' intention that this Declaration be strictly limited to and for the purposes expressed herein.

5. **Covenants.** From and after the date of this Declaration, the restrictive covenants set forth in this Declaration shall apply to the Lots Property and the Golf Course Property. The rights and restrictions specified herein (a) shall constitute a covenant running with the land; (b) shall bind every person having any fee interest in any portion of the Lots Property and Golf Course Property at any time or from time to time; and (c) shall inure to the benefit of and be binding upon the Parties and their successors-in-interest, and assigns as to the Lots Property and Golf Course Property.

6. **Enforcement.** In the event of any violation of the restrictive covenants set forth herein by any owner of the Golf Course Property, it shall be lawful for the duly formed and organized homeowners' association of which either (a) owners of a majority of the residential lots comprising the Lots Property located east of SR-18 are members, and/or (b) owners of a majority of the residential lots comprising the Lots Property located west of SR-18 are members, to prosecute any proceedings at law or in equity against the person or persons committing such violation and to enforce compliance with such covenants, conditions, or restrictions. In the event that any violation of the restrictive covenants set forth herein affects some of the eighty-six residential lots comprising the Lots Property, but not all of them, then it shall also be lawful for the owners of a majority of the lots so affected (the "Affected Lot Owners") acting collectively to prosecute any proceedings at law or in equity against the person or persons committing such violation and to enforce compliance with such covenants, conditions, or restrictions. No owner, or group of owners, of Lots Property may otherwise seek or pursue enforcement of the restrictive covenants; such enforcement actions may only be brought by a homeowners' association or, if applicable, a majority of the Affected Lot Owners, as provided above.

7. **Amendments; Waivers.** Except as provided in Section 2, this Declaration may not be modified, amended or terminated except by an instrument in writing, signed by all of the owners of the Golf Course Property and owners of a majority of the eighty-six residential lots comprising the Lots Property. No failure to exercise and no delay in exercising any right, remedy or power under this Declaration shall operate as a waiver thereof, nor shall any single or partial exercise of any right, remedy or power under this Declaration preclude any other or further exercise thereof, or the exercise of any other right, remedy or power provided herein or by law or in equity.

8. **Counterparts.** This Declaration may be executed in one or more counterparts, all of which shall be considered one and the same agreement and shall become effective when one or more counterparts have been signed by each of the Parties and delivered to the other Party personally or by mail, it being understood that all Parties need not sign the same counterpart.

9. **Appurtenance.** The restrictions created by this Declaration are appurtenant to the Lots Property and the Golf Course Property and may not be transferred, assigned or encumbered except as an appurtenance to such realty.

10. **Miscellaneous** This Declaration shall be interpreted in accordance with Utah law. If any Party or any respective successor-in-interest commences an action concerning this Declaration, the prevailing party in any such litigation shall be entitled to an award of its reasonable attorneys' fees and costs, in addition to any other appropriate remedies, whether such


