Declarant reserves unto itself and its assigns the right to create Common Area(s) and Improvements thereon, within any portion of the annexed real property. Declarant makes no assurances that such Common Areas or Improvements will be established.

Declarant hereby reserves all rights, powers, and authority granted to it in the Declaration. All property subject to this Supplemental Declaration shall be subject to the terms and conditions of the Declaration.





BEGINNING AT THE WEST ONE QUARTER CORNER OF SECTION 15, TOWNSHIP 43 SOUTH, RANGE 15 WEST, SALT LAKE BASE AND MERIDIAN; THENCE RUNNING ALONG THE ONE QUARTER SECTION LINE SOUTH 88°45'11" EAST, 745.26 FEET; SAID POINT BEING ON THE SOUTH EAST CORNER OF SYCAMORE PHASE 1; SAID POINT ALSO BEING THE POINT OF BEGINNING; THENCE RUNNING ALONG THE EAST BOUNDARY OF SYCAMORE PHASE 1 NORTH 01°09'56" EAST, 347.15 FEET TO A POINT ON THE SOUTHERN BOUNDARY OF SUN VALLEY ESTATES PHASE 7 AS RECORDED AT THE WASHINGTON COUNTY RECORDER'S OFFICE (DOC.#20120008105); THENCE ALONG SAID BOUNDARY THE FOLLOWING TWO (2) COURSES: SOUTH 88°50'04" EAST, 717.10 FEET; THENCE NORTH 01°09'56" EAST, 40.51 FEET; THENCE SOUTH 88°50'04" EAST, 125.00 FEET; SOUTH 01°09'56" WEST, 304.39 FEET; THENCE SOUTH 83°07'01" WEST, 120.08 FEET TO A POINT OF A 620.00 FOOT RADIUS NON-TANGENT CURVE TO THE LEFT (RADIUS POINT BEARS NORTH 83°07'01" EAST); THENCE 68.85 FEET ALONG THE ARC OF SAID CURVE, THROUGH A CENTRAL ANGLE OF 06°21'46" TO A POINT ON THE ONE QUARTER SECTION LINE OF SECTION 15; THENCE ALONG SAID SECTION LINE NORTH 88°45'11" WEST, 736.61 FEET TO THE POINT OF BEGINNING.
