**THIRD AMENDMENT TO THE AMENDED DECLARATION OF  
COVENANTS, CONDITIONS AND RESTRICTIONS  
OF  
LA PALOMA CONDOMINIUMS**

**RECITALS**

WHEREAS, the original Declaration of Covenants, Conditions , and Restrictions of La Paloma Condominiums was recorded in the records of the Washington County Recorder on September 16, 1994, as Entry No. 00478898, in Book 0851, beginning at Page 82 (the "Original Declaration"); and

WHEREAS, an Amended Declaration of Covenants, Conditions and Restrictions of La Paloma Condominiums was recorded in the records of the Washington County Recorder on December 14, 1994, as Entry No. 00486846, in Book 872, beginning at Page 245 (the "Amended Declaration"); and

WHEREAS, an Amendment to Amended Declaration of Covenants, Conditions and Restrictions of La Paloma Condominiums and Declaration of Annexation of La Paloma Condominiums, Phase II, was recorded in the records of the Washington County Recorder on March 31, 1995, as Entry No. 00496252, in Book 897, beginning at Page 120; and

WHEREAS, an Amendment to Amended Declaration of Covenants, Conditions and Restrictions of La Paloma Condominiums and Declaration of Annexation of La Paloma Condominiums, Phase III, was recorded in the records of the Washington County Recorder on September 15, 1995, as Entry No. 00509928, in Book 935, beginning at Page 628; and

WHEREAS, this Third Amendment to the Amended Declaration of Covenants, Conditions and Restrictions of La Paloma Condominiums ("Third Amendment") amends the Amended Declaration and any and all supplements or amendments to the Declaration prior to the date of this Third Amendment, whether or not such were recorded in the records of the Washington County Recorder. Specifically, this Third Amendment replaces and supercedes Article IX, Section 7, and Article XIII, Section 1, of the Amended Declaration. In the event of a conflict between the Declaration, the Articles of Incorporation, the Bylaws or the Rules and Regulations for the La Paloma Condominium Association, this Third Amendment shall control; and

WHEREAS, Article XIII, Section 4, of the Amended Declaration provides the Amended Declaration may be amended by an instrument signed by not less than sixty-seven percent (67%) of the owners; and

WHEREAS, on the 10<sup>th</sup> day of December 2014, a meeting was held and as evidenced in Exhibit B hereto, sixty-seven percent (67%) or more of the owners approved this Third Amendment by signing Exhibit B, which is a true and correct copy of the signatures of the owners; and

WHEREAS, this Third Amendment is made by the La Paloma Condominium Association, a Utah nonprofit corporation (the "Association") and is executed this 10<sup>th</sup> day of December 2014, which affects all the property described in Exhibit A, attached hereto. The capitalized terms in this Third Amendment shall have the same meanings and definitions of said terms as provided in the Amended Declaration.

NOW, THEREFORE, all of the Property (described in Exhibit A attached hereto and made a part hereof) shall be held, sold and conveyed subject to the Declaration as amended by this Third Amendment, which shall take effect upon the date it is recorded in the records of the Washington County Recorder ("Amendment Date").

## AMENDMENTS

NOW, THEREFORE, the La Paloma Condominium Association hereby amends the Amended Declaration of Covenants, Conditions and Restrictions of La Paloma Condominiums as follows:

A. NOW, THEREFORE, Article IX, Section 7, of the Amended Declaration, titled "Quiet Enjoyment" is hereby replaced in its entirety and amended to read as follows:

### Section 7. Quiet Enjoyment.

(a) No noxious or offensive activity shall be carried on upon any part of the properties nor shall anything be done thereon which may be or may become an annoyance or nuisance to the neighborhood, or which shall in any way interfere with the quiet enjoyment of each of the owners or which shall in any way increase the rate of Insurance.

(b) The Condominium Project shall be a non-smoking community. To the fullest extent permitted by law, including without limitation the Condominium Ownership Act, Utah Code 57-8-1, *et seq.*, and the Utah Indoor Clean Air Act, Utah Code 26-38-1, *et seq.*, the smoking of tobacco and/or nicotine products in any form intended for inhaling, exhaling, burning or heating through an oral smoking device, cigar, cigarette, e-cigarette, pipe, bong or hookah, within the Condominium Project by owners, members, their family members, tenants, guests, or invitees constitutes a nuisance and therefore is prohibited at all times and all places within the Condominium Project, including without limitation in the Common Areas and Facilities, Limited Common Areas, stairways, exterior walkways, driveways, yards, recreational areas and facilities, Condominiums and Units anywhere within the Condominium Project. Unit Owners shall be

responsible for the conduct of themselves, their family members, tenants, guests, and invitees. Infractions of this provision shall, after notice and an opportunity for a hearing, be subject to a fine, charge and/or fee as provided by Utah law, the Declaration, Bylaws, Rules and Regulations and any other governing documents of the Association.

The Association, Management Committee, or any Unit Owner is specifically empowered to bring suit against a Unit Owner for all infractions of this provision, and the suit may seek to enjoin further violations, collect any fines or charges levied hereunder, or both. In the event legal action is necessary to enforce this provision, the Association, Management Committee or Unit Owner shall be entitled to an award of all reasonable costs and all attorney's fees incurred in the enforcement hereof, including costs and attorney's fees incurred prior to the commencement of litigation, if an action is filed.

B. NOW, THEREFORE, Article XIII, Section 1, of the Amended Declaration titled "Enforcement" is hereby replaced in its entirety and amended to read as follows:

Section 1. Enforcement. The Association, Management Committee, or any Unit Owner shall have the right to enforce, by any proceeding at law or in equity, all restrictions, conditions, covenants, reservations, liens, charges, fines and/or fees now or hereafter imposed by the provisions of the Declaration, Bylaws, or any rule of the Association, including but not limited to any proceeding at law or in equity against any person or persons violating or attempting to violate any covenant or restriction, either to restrain violation or to recover damages, and against the land to enforce any lien created by these covenants. Failure of the Association, Management Committee or any owner to enforce any covenant or restriction herein contained or any rule of the Association shall in no event be deemed a waiver of the right of the Association, Management Committee or any owner to do so thereafter. In the event action, with or without suit, is undertaken to enforce any provision hereof or any rule or bylaw of the Association, the party against whom enforcement is sought shall pay to the Association, Management Committee, or enforcing owner reasonable attorney fees and costs. The Association or Management Committee may levy a charge, fee, or fine not to exceed ten percent (10%) of the amount of the maximum annual assessment against any owner and/or occupant, and/or owner's agent for each violation of the Declaration, Bylaws, or any rule of the Association if said violation is not cured within three (3) days of the notice of violation and an opportunity for a hearing has been provided.

Said charges and fees may be collected in the same manner as Assessments as outlined in Article V of the Declaration. Further, fines may also be collected in the same manner as Assessments as outlined in Article V of the Declaration provided one-hundred eighty (180) days has passed from the day on which a final decision from the hearing is issued or one-hundred eighty (180) days after the day on which the time to request a hearing expired. The Association and/or the Management Committee, including its members, shall not be liable to any lessee, tenant, Unit Owner, member or other person for mistake in judgment, or for any negligence arising in connection with the performance or nonperformance of duties under the Declaration or Bylaws.

The following procedures shall govern a hearing of the Association or Management Committee:

- (a) **Scheduling a Hearing/Continuances/Failure to Appear:** The hearing shall, within reason, be conducted within seven (7) days from the receipt of the request. The Association or Management Committee shall give notice of the date, time, and location of the hearing to the requesting Owner. Notice of the hearing shall be delivered to the requesting person/owner at the last known address by USPS first-class mail, postage prepaid, hand delivery or e-mail if the requesting party consents to notice by e-mail. If the hearing date is unacceptable to the requesting person/Owner, they shall be entitled to one (1) continuance of the hearing date. To receive a continuance, the requesting person/Owner shall deliver a written request for continuance to the Association or Management Committee. The request must be received by the Association or Management Committee prior to the original hearing date. The request for continuance shall contain three (3) alternate dates and times when the requesting Owner may meet. The alternate dates shall not exceed twenty-one (21) days from the original hearing date. Failure by a requesting person/Owner to appear at a hearing or continued hearing shall result in a waiver of the requesting person/Owner's right to hearing and the fine(s), charge(s) and/or fee(s) shall be deemed uncontested.
- (b) **Hearing Procedures/Decision:** The hearing shall be conducted by a minimum of three (3) persons who may be members of the Management Committee. The requesting person/Owner shall be given fifteen (15) minutes to present his/her case, unless for cause shown a longer period of time is required. The requesting person/Owner may present documentation or witnesses in support of his/her case. The Management Committee, or other persons conducting the hearing, may question the requesting person/Owner or witnesses during the hearing. In the event there is a complaining Owner at the hearing, such party shall have an equal time to present their case. After hearing the requesting person/Owner's position and evidence, the Management Committee, or other persons conducting the hearing, may either render its decision at the hearing or take the evidence and argument under advisement. If the matter is taken under advisement, they shall render a final decision within seven (7) business days of the hearing. Once a decision is rendered, written notice of the decision shall be provided to the requesting person and Owner. In the case of a fine(s), as part of the decision, the person/Owner found in violation shall be informed payment of the fine is due within fourteen (14) days or interest and late fees will accrue. All decisions of the Management Committee are final.

IN WITNESS WHEREOF, on the 10<sup>th</sup> day of DECEMBER, 2014, the President of the Association hereby represents that a meeting was held regarding this Third Amendment to the Amended Declaration and sixty-seven percent (67%) or more of the owners approved of the Third Amendment to the Amended Declaration. Exhibit B hereto contains true and correct copies of the signatures of the members/owners that assent to this Third Amendment.
