KNOW ALL MEN BY THESE PRESENTS:

That is copy of consideration of One Dollar (\$1.00) and other good and valuable consideration paid to

hereinafter referred to as GRANTOR, by St. George City and Santa Clara Town,

hereinafter referred to as GRANTEE, the receipt of which is hereby acknowledged, the GRANTOR does hereby grant, assign, sell, transfer, and convey unto the GRANTEE, its successors and assigns, a perpetual easement with the right to erect, construct, install, and lay, and thereafter use, of, real, personal, repair, maintain, replace, and remove

A culinary water line, powerline and roadway... across, and through the land of the GRANTOR situated in Washington County,state of Utah, said land being described as follows:From the NW 1/4, SW 1/4, and the SE 1/4, SW 1/4 of Section 3, T42S, RIGH, SIRBH.

either with the right of ingress and egress over the adjacent lands of the GRANTOR, his successors and assigns, for purposes of this easement.

The easement shall be 120 feet in width, the center line of which is described as follows:

PARCEL F - A 120 foot right-of-way whose centerline is described as follows:

Beginning at a point N90°E, 483.09 feet, more or less from the NW 1/4 corner of Section 3, T42S, RIGH, SIRBH; said point being on the South line of the SW 1/4, NW 1/4 of said Sec. 3; thence 552°45'05"E, 841.35 feet; thence 834°05'05"E, 2565.24 feet; to a point on the North line of the NE 1/4, NW 1/4 of Section 10, T42S, RIGH, SIRBH; said point being N90°W, 115.85 feet, more or less from the NW 1/4 corner of said Section 10; thence 827°46'56"E, 378.66 feet.

The consideration hereinabove recited shall constitute payment in full for any damages to the land of the GRANTOR, his successors and assigns, by reason of the installation, operation, and maintenance of the structures or improvements used to herein. The GRANTEE covenants to maintain the easement in good repair so that no unreasonable damage is caused to the adjacent land of the GRANTOR, his successors and assigns.

The plant and other fixtures of this easement shall constitute a collateral tenancy with the land for the benefit of GRANTEE, its successors and assigns.


