**FIFTH AMENDMENT AND ANNEXATION AMENDMENT TO DISTRICT
 DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS AND
 RESERVATION OF EASEMENTS, AND BYLAWS FOR CASITAS AT SIENNA HILLS
 (a part of the Expandable Sienna HILLS Planned Mixed Use Development)**

This Fifth Amendment and Annexation Amendment to District Declaration Of Covenants, Conditions, And Restrictions And Reservation Of Easements, And Bylaws For Casitas At Sienna Hills (the "Fifth Amendment") is made this 9th day of March, 2017, by Ivory Southern, LLC, ("District Declarant").

RECITALS

- A. On February 17, 2015, District Declarant caused to be filed for record in the office of the County Recorder of Washington County, Utah, the District Declaration Of Covenants, Conditions, And Restrictions And Reservation Of Easements, And Bylaws For Casitas At Sienna Hills (the "District Declaration"), which was recorded as Doc # 20150005111, of the Official Records of Washington County.
- B. Pursuant to Section 17.5 of the District Declaration, District Declarant may unilaterally amend the Declaration.
- C. On November 12, 2015, District Declarant caused to be filed a First Amendment to the District Declaration which was recorded as Doc # 20150039533.
- D. On April 11, 2016, District Declarant caused to be filed a Second Amendment to the District Declaration which was recorded as Doc # 20160012384.
- E. On April 28, 2016, District Declarant caused to be filed a Third Amendment to the District Declaration which was recorded as Doc # 20160014747.
- F. On April 29, 2016, District Declarant caused to be filed a Fourth Amendment to the District Declaration which was recorded as Doc # 20160014899, which annexed all of Phase 2.
- G. The District Declarant has determined that to provide for the preservation and enhancement of the property value that said District Declaration be amended to annex certain real property to expand the property subject to the District Declaration as hereinafter set forth.

NOW, THEREFORE, for the foregoing purposes, the District Declarant hereby amends said District Declaration as follows.

ANNEXATION

This is a Declaration of Annexation prepared pursuant to Article II Submission of the District Declaration.

Casitas At Sienna Hills Phase 3, consists of Lots 56, 57, 58, 59, 68, 69, 70, 71, 72, 73, 74,

District Declarant intends and hereby subjects the Phase 3 Lots and the associated District Common Area and District Limited Common Area to the terms of the District Declaration, as amended from time to time, which property is set forth in Exhibit A. The Phase 3 Lots and the District Common Area and District Limited Common Area are located on the following described property in Washington County, State of Utah, including Lots, District Common Area and District Limited Common Area as set forth on the Plat filed for Phase 3:

(hereinafter referred to as the "Phase 3 Property")

The District Declarant hereby consents to the annexation of the Phase 3 Property into the Casitas at Sienna Hills and further declares that the Phase 3 Property shall hereafter be held, sold, conveyed, encumbered, leased, used, occupied and improved as part of the District Land (as that term is used in the District Declaration) and subject to the District Declaration, as amended, and all protective covenants, conditions, restrictions and equitable servitudes set forth in the District Declaration, as amended from time to time, the terms of which are deemed incorporated herein by this reference, and to the jurisdiction of the Association and entitled to all rights and privileges afforded therein. The covenants, conditions and restrictions of the District Declaration are intended to, and shall in all cases run with the title of the land, and be binding upon the successors, assigns, heirs, lien holders, and any other person holding any interest in the Phase 3 Property, and shall inure to the benefit of all other lots that are subject to the District Declaration, as amended from time to time. The covenants, conditions and restrictions of the District Declaration, as amended, shall be binding upon the Casitas at Sienna Hills District Association and the District Declarant as well as their successors in interest, and may be enforced by them or by an owner of a District Lot to the extent provided in the District Declaration.

District Declarant and the District Association hereby declare that the Phase 3 Property is added to and made a part of the District Land subject to the District Declaration. The Phase 3 Property is and shall be held, conveyed, hypothecated, encumbered, leased, occupied, built upon or otherwise used, improved or transferred in whole or in part, subject to the District Declaration, as amended from time to time.

The District Declaration is amended to annex the following described real property to expand the property which shall be hereafter subject to the District Declaration, as amended from time to time.

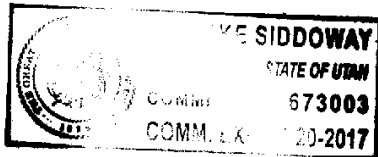
