TOWNSHIP 2 SOUTH, RANGE 1 EAST, UTAH SPECIAL MERIDIAN.





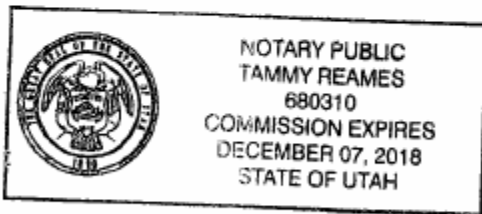
