**AMENDMENT TO DECLARATION OF  
COVENANTS, CONDITIONS AND RESTRICTIONS OF BRIER RIDGE P.R.U.D**

The Declarant, Brier Ridge, LLC recorded its Covenants, Conditions and Restrictions for Brier Ridge P.R.U.D. with the Weber County Recorder's office on March 25, 2002 as Entry No. 1836081 in Book 2219 at Page 1046 (hereinafter "Declaration"). At the time that said Declaration was recorded it related to the real property consisting of Brier Ridge, Phase 1 which consists of sixteen (16) four-unit buildings for a total of 64 (sixty-four) units. Said Declaration further referenced undeveloped land which would be annexed into the Brier Ridge project at a future date. The purpose of this Amendment is to expand the real property subject to the Declaration and to notify all future owners of said property that they are subject to all of the provisions contained in the Declaration including but not limited to the homeowner's association.

Declarant hereby annexes all of said undeveloped land into the Brier Ridge project and further imposes all of the same covenants, conditions and restrictions relating to Brier Ridge P.R.U.D Phase 1 onto the undeveloped land which shall be developed into Phase 2 and Phase 3 of Brier Ridge P.R.U.D. Pursuant to its rights under the original Declaration and as the sole owner of the real property, the property which is now annexed into Brier Ridge PRUD consists of the real property situated in Weber County, State of Utah described in Exhibit "A" hereto. It is intended that the property in Exhibit "A" shall be subdivided into Phase 2 consisting of 18 buildings (72 total units) and Phase 3 consisting of 13 buildings (52 total units).

All of the property described in Exhibit "A" is and shall be held, transferred, sold, conveyed and occupied subject to the provisions of the Declaration recorded as Entry No. 1836081. Therefore, from the date of recording of this instrument all of the real property more particularly described in Exhibit "A" attached hereto shall be subject to the covenants, conditions and restrictions set forth in the Declaration and any valid amendment thereto.

It is further the intention of the Declarant that Brier Ridge Subdivision shall include one homeowner's association for all lot owners regardless of the phase in which their unit is platted. The covenants governing that homeowner's association are set forth in the Declaration. Except as herein set forth, no other provision of the Declaration of Covenants, Conditions and Restrictions of Brief Ridge PRUD is amended by this instrument.

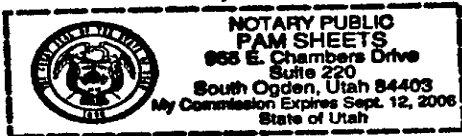
