- Miscellaneous. Except as hereby amended, the Declaration shall in all other particular terms and conditions remain in full force and effect. In the event of any inconsistency between the terms and conditions set forth in the Declaration and this Amendment, the terms and conditions of this Amendment shall prevail. This Amendment may be executed in any number of separate counterparts, each of which when so executed and delivered shall be deemed original, but all such counterparts together shall constitute but one and the same instrument.
