



# AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF MOOSE HOLLOW CONDOMINIUM PROJECT

#### RE-NUMBERING OF INDIVIDUAL UNITS IN BUILDINGS 7, 8 AND 9 - PHASE IV

The individual units in Buildings 7, 8 and 9 are hereby re-numbered as shown in the amended plat submitted herewith.

The Management Committee of the Moose Hollow Condominium Project hereby certifies that this amendment has been adopted by the affirmative vote of at least 65% of the undivided ownership interest in the Common Areas and Facilities as required by paragraph III. 42.
