This restriction shall be considered a covenant and restriction that runs with the land and may only be amended, released, or waived by a written instrument signed by Grantor.

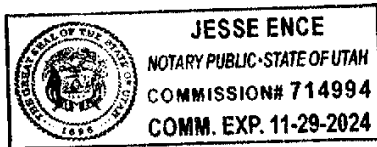
