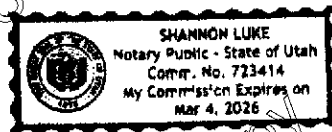

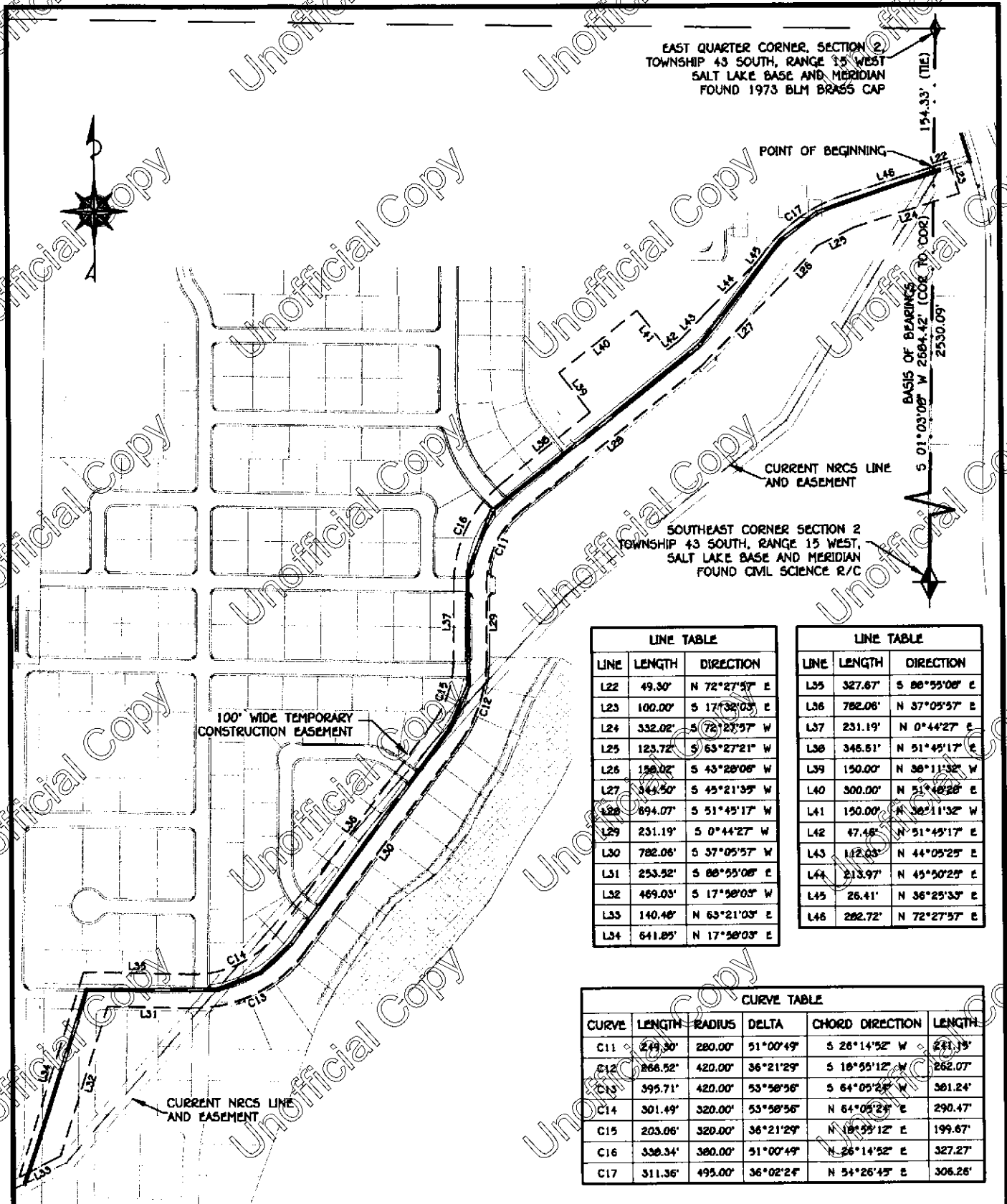


EXHIBIT A
