**SECOND RATIFICATION, CONSENT AND ASSIGNMENT OF DECLARANT'S
RIGHTS**

(Re: The Indigo Trails Subdivision)

THIS SECOND RATIFICATION, CONSENT AND ASSIGNMENT OF DECLARANT'S RIGHTS ("Assignment") is made effective on the 13th day of April, 2018 ("Effective Date"), by and between Cowichan, LLC, a Utah limited liability company ("Assignor"), and A N A Enterprises, LLC, a Utah limited liability company ("Assignee").

RECITALS

WHEREAS, pursuant to that certain Ratification, Consent and Assignment of Declarant's Rights recorded with the Washington County Recorder as Entry No. 20240000846, Assignor has been assigned the rights of the "Declarant", as defined in the Declaration of Covenants, Conditions and Restrictions for Indigo Trails Subdivision, a residential subdivision located in Ivins, Utah, recorded with the Washington County Recorder on September 9, 2016 as Doc. No. 20160033357 ("CC&Rs");

WHEREAS, Section 9.1 of the CC&Rs provides as follows:

"Declarant may expand the real property subject to these CC&Rs by the annexation of Annexable Land. Annexation may be accomplished in one or more annexations or Phases of Development without limitation, as to size or location within the Annexable Land. When annexation becomes effective, said real property shall be subject to and restricted by these CC&Rs, and subject to the functions, powers, and jurisdiction of the Association, and thereafter all of the Owners of Homesites in the land annexed into the Development shall automatically become Members of the Association."

WHEREAS, Exhibit C to the CC&Rs defines "Annexable Land" as follows;

"Annexable Land means real property contiguous to the 22.25-acre tract of land in Ivins City, Utah known [sic] as Indigo Trails, or any real property with a boundary line that is within 3,000 feet of the Development."

WHEREAS, Section 10.6 of the CC&Rs allows Assignor, as Declarant by assignment, to further assign Declarant rights under the CC&Rs;

WHEREAS, the time period for Declarant rights referred to in Section 10.6 has not expired;

WHEREAS, the CC&Rs are deemed covenants that run with the land;

WHEREAS, at all relevant times, Assignor was and is the owner of certain real property described in **Exhibit A**, which is located within the Indigo Trails Subdivision or is part of the Annexable Land;

WHEREAS, at all relevant times, Assignee was and is the owner of certain real property described in **Exhibit B** (the "Property"), which is subject to the CC&Rs, and is part of the Annexable Land;

WHEREAS, on the Effective Date, Assignor orally conveyed and assigned to Assignee, and Assignee received and assumed, all of the Assignor's rights and duties as Declarant under the CC&Rs as provided for herein;

WHEREAS, Assignor and Assignee desire to memorialize the terms of said oral conveyance and assignment in writing as set forth herein below, and Assignee shall record this Assignment against the property described in **Exhibit A**, **Exhibit B**, and properties located within the Indigo Trails Subdivision, which are more particularly described in **Exhibit C**.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the terms and conditions of the CC&Rs, Assignor and Assignee hereby agree as follows:

1. Recitals Incorporated. The Recitals set forth above are incorporated herein as part of this Assignment.

2. Assignment. As of the Effective Date, Assignor hereby conveys and assigns to Assignee any and all of the Declarant's rights and duties that Assignor has.

3. Consent. Further, Assignee accepts KDI's acts in recording the Supplemental Declarations as its own.

4. Ratification. Assignee hereby ratifies and confirms KDI's recording of the Supplemental Declarations.

5. Assumption. From and after the Effective Date, Assignee hereby assumes all of the Declarant's rights and duties under the CC&Rs.

6. Assignee's Indemnification of Assignor. Assignee shall and does hereby agree to indemnify Assignor against, and agrees to hold Assignor harmless of and from, all liabilities, obligations, actions, suits, proceedings or claims, and all losses, costs, and expenses, including, but not limited to, reasonable attorneys' fees, arising from circumstances related to Declarant rights and duties arising on and after the Effective Date.

7. Assignor's Indemnification of Assignee. Assignor shall and does hereby agree to indemnify Assignee against, and agrees to hold Assignee harmless of and from, all liabilities, obligations, actions, suits, proceedings or claims, and all losses, costs, and expenses, including, but not limited to, reasonable attorneys' fees, arising from circumstances related to Declarant rights and duties arising before the Effective Date.

8. Binding Effect. This Assignment shall inure to the benefit of and shall be binding upon the parties hereto and their respective successors and assigns.

9. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Utah, without giving effect to its conflict of laws principles.

10. Authorization. The individuals signing for the respective entities make the following representations: (i) he/she has read this Assignment; (ii) he/she has authority to act for the entity designated below; and (iii) he/she shall execute this Assignment acting in said capacity.

11. Legal Counsel. Assignor and Assignee hereby agree that they have executed this Assignment voluntarily, without coercion or duress of any kind, and have had the opportunity to consult with independent counsel regarding same.

12. Counterparts. This Assignment may be executed in any number of counterparts, provided each counterpart is identical in its terms. Each such counterpart, when executed and delivered will be deemed to be an original, and all such counterparts shall be deemed to constitute one and the same instrument. For convenience in recording, signature pages from multiple counterparts may be detached from their counterparts and attached to a single counterpart to be recorded.




