THIS NOTICE OF REASSIGNED UNIT NUMBERS ("Notice") is made as of September 25, 2024 ("Effective Date") by ENLAW LLC, a Delaware limited liability company ("Owner"), with reference to the following:

A. Owner recorded that certain Black Desert Villages Condominiums Phase 1A Subdivision Plat, prepared by Alpha Engineering, recorded in the Official Records of the Washington County Recorder's Office ("Official Records") on February 28, 2024, as Document No. 20240005982, Black Desert Villages Condominiums Phase 1B Subdivision Plat, prepared by Alpha Engineering, recorded in the Official Records on February 28, 2024 as Document No. 20240005983, Black Desert Villages Condominiums Phase 1C Subdivision Plat, prepared by Alpha Engineering, recorded in the Official Records on February 28, 2024 as Document No. 20240005984, and Black Desert Villages Condominiums Phase 2A Subdivision Plat, prepared by Alpha Engineering, recorded in the Official Records on February 28, 2024 as Document No. 20240005985 (collectively, the "Prior Plats"), affecting certain real property owned by Owner and located in Washington County, State of Utah (the "Property") as described on Exhibit A attached hereto and made a part hereof.




