**NOTICE OF CANCELATION AND RESCISSION OF

AMENDED AND RESTATED  
COVENANTS, CONDITIONS, AND RESTRICTIONS (CC&R'S)**

**7<sup>th</sup> AMENDMENT**

**Recorded January 11, 2024, as Document No. 20240001160**

This Notice of Cancelation and Recission of Harrisburg Estates Owners Association Amended and Restated Covenants, Conditions, and Restrictions (CC&Rs) 7<sup>th</sup> Amendment ("Notice") is made by the Harrisburg Estates Owner's Association.

**RECITALS:**

A. The Harrisburg Estates Owners Association Amended and Restated Covenants, Conditions, and Restrictions (CC&R's) 7<sup>th</sup> Amendment, was recorded with the Washington County Recorder on January 11, 2024, as Document No. 20240001160 (the "1/11/24 7<sup>th</sup> Amendment").

B. The 1/11/24 7<sup>th</sup> Amendment was to amend and replace the Harrisburg Estates Homeowners Association Covenants, Conditions & Restrictions 6<sup>th</sup> Amendment, recorded with the Washington County Recorder on October 27, 2009 (the "6<sup>th</sup> Amendment").

C. The 6<sup>th</sup> Amendment provides that "[t]hese CC&Rs may be amended at any time by an instrument signed by Owners representing not less than fifty one (51%) percent of the lots."

D. While the 1/11/24 7<sup>th</sup> Amendment was voted on and approved by the lot owners, such approval was not evidenced by a signed instrument and the procedural requirements for amendment were not properly followed.

E. This Notice is intended to cancel and rescind the 1/11/24 7<sup>th</sup> Amendment and provide notice to current and future owners of affected properties that such 1/11/24 7<sup>th</sup> Amendment is not binding against the properties.

F. This Notice does not affect the Harrisburg Estates 6<sup>th</sup> Amendment, Bylaws, or Plats on file with the Washington County Recorder and such documents shall remain in full force and effect.

G. This Notice affects the real property located in Washington County, State of Utah, described in particularity in **Exhibit A**, which exhibit is attached hereto and incorporated by reference.

NOW THEREFORE, in consideration of the foregoing Recitals, and for the benefit of the Harrisburg Estates Owner's Association, NOTICE IS HEREBY GIVEN that the 1/11/24 7<sup>th</sup> Amendment, is hereby canceled and rescinded.


