





Beginning at a point on the west Line of Parcel No. H-3-1-31-1118, which lies North 88°56'23" West 1,257.67 feet along the section line and South 1,681.81 feet, from the Northeast Corner of Section 31, Township 41 South, Range 13 West, Salt Lake Base and Meridian; Running thence South 88°58'50" East 257.00 feet; thence southeasterly along a 25.00 foot radius curve to the right, (center point lies South 01°01'10" West) through a central angle of 90°00'00", a distance of 39.27 feet; thence South 01°01'10" West 229.06 feet; thence southerly along a 138.00 foot radius curve to the left, (center point lies South 88°58'50" East) through a central angle of 26°03'07", a distance of 62.75 feet; thence South 25°01'57" East 260.40 feet; thence southeasterly along a 214.00 foot radius curve to the left, (center point lies North 64°58'03" East) through a central angle of 64°04'50", a distance of 239.34 feet; thence South 89°06'47" East 595.15 feet; thence South 00°52'43" West 72.00 feet; thence North 89°06'47" West 595.17 feet; thence northwesterly along a 286.00 foot radius curve to the right, (center point lies North 00°53'13" East) through a central angle of 64°04'50", a distance of 319.87 feet; thence North 25°01'57" West 260.40 feet; thence northerly along a 210.00 foot radius curve to the right, (center point lies North 64°58'03" East) through a central angle of 26°03'07", a distance of 95.49 feet; thence North 01°01'10" East 177.06 feet; thence northwesterly along a 5.00 foot radius curve to the left, (center point lies North 88°58'50" West) through a central angle of 90°00'00", a distance of 7.85 feet; thence North 88°58'50" West 210.00 feet; thence North 01°01'10" East 62.00 feet; thence South 88°58'50" East 5.00 feet; thence North 01°01'10" East 10.00 feet to the point of beginning.
