
**NOTICE OF LOT LINE ADJUSTMENT APPROVAL**

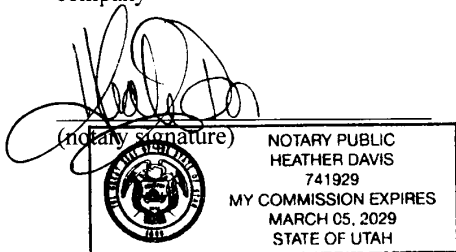
