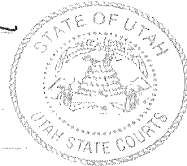

JUDGMENT

This matter came before the Court, on Plaintiffs' Motion for Summary Judgment, which the Court granted on August 5, 2025. The court, having reviewed the pleadings and supporting exhibits and declarations of the respective parties, and good cause appearing therefore, finds as follows:

1.

In or about late-2022, Defendant Raymond Ebert (“Defendant”) approached Bundy about a business investment.

2.

Defendant was looking for investors for his company, Quail Lake Sunset RV, LLC (“Quail Lake”), a Utah limited liability company.

3.

Quail Lake Sunset RV, LLC, was a façade for Defendant’s own personal operations.

4.

Quail Lake Sunset RV, LLC, was an alter ego for Defendant, Raymond Ebert.

5.

Defendant Raymond Ebert should be held personally liable for any liability against Quail Lake Sunset RV, LLC.

6.

Defendant represented to Plaintiffs that Quail Lake was to purchase real property located at 5698 W. 155 N. Hurricane, UT 84737 (the “Property”).

7.

Defendant represented to Plaintiffs that the Property was to be developed by Quail Lake to be an RV Park.

8.

Defendant knew his statement was false when he represented to Plaintiffs that he intended to have Quail Lake purchase the Property.

9.

Defendant's true purpose was to have Plaintiffs pay him \$75,000.00.

10.

Defendant presented to Bundy that if she invested \$75,000.00 into Quail Lake, then she would receive a return of at least \$220,000.00.

11.

Defendant told Bundy that her investment would be used to purchase the Property.

12.

On or about November 1, 2022, Bundy and Quail Lake entered into a Utah Joint Partnership Agreement, dated October 31, 2022 ("Agreement").

13.

Pursuant to the terms of the Agreement, Bundy would pay Quail Lake \$75,000.00, on or before November 4, 2022.

14.

On November 2, 2022, Bundy, through her company Pink Estates, LLC, transferred the agreed upon \$75,000.00 at Defendant's instruction.

15.

Defendant used Plaintiffs' \$75,000.00 to make payments to Sunfarms, LLC ("Sunfarms"), a Utah limited liability company.

16.

Defendant Raymond Ebert and his wife, Elizabeth Ebert, control Sunfarms, LLC.

17.

Defendant used Sunfarms, LLC, to promote injustice and fraud by using Sunfarms to pay themselves Plaintiffs' \$75,000.00 that was deposited for the purpose of developing Quail Lake into an RV Park.

18.

Sunfarms, LLC, is the alter ego of Defendant and Defendant should be personally liable for any liability against Sunfarms, LLC.

19.

Due to Defendant's actions, Plaintiffs have been damaged in the amount of no less than \$220,000.00.

IT IS HEREBY ORDERED AND DECREED that Plaintiffs, Pink Estates, LLC, a Utah limited liability company ("Pink Estates"), and Rebecca Bundy, an individual ("Bundy") (Bundy together with Pink Estates as "Plaintiffs"), have and recovered a judgment against Defendant, Raymond Ebert in favor of Plaintiffs for breach of contract, breach of the covenant of good faith and fair dealing, fraud committed by Defendant, and using Sunfarms, LLC, to siphon funds from Plaintiffs, in an amount of \$220,000.00, plus the cost of suit in the amount of \$375.00, plus \$230.00 for service of process, plus reasonable attorney's fees as of the date of this submission in the amount of \$19,250.64, plus future reasonable attorney's fees owed in collection of this judgment, plus pre- and post-judgment interest at the statutory rate 10% per annum from the date of the default through the date when the principal amount is paid in full, for a total judgment amount of \$239,855.64.
