This prohibition, however, is not intended to exclude the occupancy or use by persons not of the Caucasian Race, while employed as servants on the premises. Also by amending Clause No. 7, under General Provisions, so that the same shall road as follows: The ground floor area of any residence, not including utility rooms, porches and garages, shall be not less than 850 square feet in the case of a one-story structure nor less than 850 square feet in the case of a one-and one-half or two story dwelling, provided that in the case of two family dwellings, each of the two dwelling units shall have the minimum square foot area required therein.
