BE IT ORDAINED BY THE CITY COUNCIL OF SUNSET CITY, UTAH:

Section 1. That the Owners' petition for vacation of easement and dedication of new easement in Scottsdale Subdivision, Sunset City, Utah, heretofore presented to Sunset City be and the same is hereby approved and accepted.

Section 2. That the present and existing easement for utility purposes described as follows:

A strip of land 10 feet wide, parallel to and 5.00 feet each side of the following described centerline: Beginning at a point South 89° 56' 00" East 5.00 feet from the Southwest corner of said Scottsdale Subdivision and running thence North 0° 13' 17" East 2229.93 feet to a point South 89° 56' 00" East 5.00 feet from the Northwest corner said Scottsdale Subdivision.

be and the same is hereby set aside and vacated.

Section 3. That the following described property, to-wit:

A strip of land 10 feet wide, parallel to and 5.00 feet each side of the following described centerline: Beginning at a point South 89° 56' 00" East 34.00 feet from the Southwest corner of said Scottsdale Subdivision, and running thence North 0° 02' 00" East 2229.80 feet to a point South 89° 56' 00" East 26.70 feet from the Northwest corner of said Scottsdale Subdivision.

and the dedication of same as a public easement for public utilities be and the same is hereby approved, ratified and accepted by the Mayor and City Council of Sunset City and by Sunset City, a municipal corporation.
