ORDINANCE NO.

AN ORDINANCE VACATING UTILITY EASEMENT IN
SCOTT-DALE SUBDIVISION AND ACCEPTING DEDI-
CATION OF NEW EASEMENT.

Scott-Dale Job 1-31, sec. Blk 5

BE IT ORDAINED BY THE CITY COUNCIL OF SUNSET CITY, UTAH:

Section 1. That the Owners' petition for cessation of easement and dedi-
cation of new easement in Scott-Dale Subdivision, Sunset City, Utah, heretofore
presented to Sunset City be and the same is hereby approved and accepted.

Section 2. That the present and existing easement for utility purposes de-
scribed as follows:

A strip of land 10 feet wide, parallel to and 5.00 feet each side of
the following described centerline: Beginning at a point South 87°
56' 00" East 5.00 feet from the Southwest corner of said Scott-Dale
Subdivision and running thence North 0° 13' 17" East 2229.83 feet
to a point South 87° 56' 00" East 5.00 feet from the Northwest
corner said Scott-Dale Subdivision.

be and the same is hereby set aside and vacated.

Section 3. That the following described property, to-wit:

A strip of land 10 feet wide, parallel to and 5.00 feet each side of
the following described centerline: Beginning at a point South
87° 56' 00" East 34.00 feet from the Southwest corner of said Scott-
Dale Subdivision, and running thence North 0° 02' 00" East 2229.80
feet to a point South 87° 56' 00" East 26.70 feet from the Northwest
corner of said Scott-Dale Subdivision

and the dedication of same as a public easement for public utilities be and the same
is hereby approved, ratified and accepted by the Mayor and City Council of Sunset
City and by Sunset City, a municipal corporation.
