Stagecoach Run, Eagle Mountain City, Utah 84005 ("Grantor") for good and valuable consideration, receipt of which is hereby acknowledged, hereby quitclaims and conveys to **STATE OF UTAH, SCHOOL AND INSTITUTIONAL TRUST LANDS ADMINISTRATION** ("Grantee") all right, title, and interest of Grantor in and to the following described property located in Utah County, Utah:

**PONY EXPRESS TRAIL C2 (A portion of Parcel #58:054:0016)**

**A part of Section 36, Township 5 South, Range 2 West, Salt Lake Base and Meridian, located in Eagle Mountain City, Utah County, Utah, being more particularly described as follows:**

**Beginning at a point on the Southeast corner of the property described in EXCHANGE PATENT NO. 20570, Entry No. 92010:2018 recorded on September 25, 2018 in the office of the Utah County Recorder; said point located S00°36'01W 2303.56 feet along the Section line and West 1586.82 feet, from the Northeast Corner of said Section 36. (Basis of bearing being: N89°36'58W between the Northeast Corner and the North Quarter Corner of Said Section 36) thence Southerly along the arc of a non-tangent curve to the right having a radius of 215.57 feet (radius bears: S40°49'58"W) a distance of 276.87 feet through a central angle of 73°35'11" Chord: S12°22'26"E 258.23 feet; thence N61°32'50"W 168.82 feet; thence N28°27'07"E 195.40 feet to the point of beginning.**


