POLE LINE EASEMENT

THOMAS A. DAVENPORT and MRS. MURIEL DAVENPORT, his wife,
and BONNEVILLE MUTUAL INC., a corporation
doing business in the State of Utah, Grantors hereby conveys and warrants to UTAH POWER & LIGHT
COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar
and other valuable consideration, a perpetual easement and right of way for the erection and continued
maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits
of the Grantee, and one guy anchor and one poles, with the necessary
guys, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be
erected and maintained upon and across the premises of the Grantors, in Salt Lake
County, Utah along a line described as follows:

Beginning at the west boundary line of the Grantors' land at a point 300 feet
north and 364 feet east, more or less, from the southwest corner of Section 20,
T. 3 S., R. 1 E., S.L.M., thence East 187 feet on said land and being in the SW 1/4
of the SW 1/4 of said Section 20.

Together with all rights of ingress and egress necessary or convenient for the full and complete use,
occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto,
including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions
which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
