GEORGE STAPLES, AND MARGIE STAPLES, single persons grantors of Eden County of Weber State of Utah, hereby grants, bargains and sells to the State-Road-Commissioner-of-Utah- Weber County, Grantee, for the sum of Two Hundred Two & 50/100 (\$202.50 ) Dollars, the following described right of way across the grantors land in Weber County, State of Utah, as follows:

Right of way for highway known as WPSO project No 193 across the grantors land in the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 6 T. 6 N.R.2 E. S.L.B. & M. Said right of way is a strip of land 40 ft. wide on the easterly side and extends to the west section line of section 6 on the westerly side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the west boundary line of said grantors land and said center line of survey at Engineers Station 108+39.0 which point is 685.2 ft. southerly along the West line of said Section 6, from the northwest corner of said Section 6; thence Southerly 143.7 ft along the arc of 6°00' Curve to the right to the point of "curve to spiral", said 6°00' curve being tangent at the point of beginning to a line bearing S 17°07' E.; thence southerly and to the right 300.0 ft. along the arc of a 300 ft. Right of way for highway known as WPSO project No 193 across the grantors land in the N  $\frac{1}{2}$  of NE  $\frac{1}{4}$  of Section 1, T. 6 N. R. 1 E. S.L.B.& M. Said right of way is contained within a tract of land 33.0 ft. wide on the northerly side of the center line of survey of said project between Engineers Stations 90+33.5 and 96+80.0 and 33.0 ft. wide on the southerly side between engineers Stations 90+33.5 and 94+85.8 and is bounded by a straight line from a point 33.0 ft.
