A RESOLUTION OF THE CITY COUNCIL OF SALINA CITY, SEVIER COUNTY, STATE OF UTAH, CREATING A SPECIAL IMPROVEMENT DISTRICT TO BE KNOWN AS "SALINA CITY SOUTHEAST IMPROVEMENT DISTRICT" TO CONSTRUCT IMPROVEMENTS WITHIN SAID DISTRICT CONSISTING OF ROADS AND SIDEWALKS TOGETHER WITH ACQUISITION OF NECESSARY PROPERTY; TO DEFRAY THE COSTS AND EXPENSES OF SAID IMPROVEMENTS BY SPECIAL ASSESSMENTS TO BE LEVIED AGAINST THE PROPERTY BENEFITED BY SUCH IMPROVEMENTS; AND PROVIDING FOR THE ISSUANCE OF INTERIM FINANCING AND THE METHOD OF PAYING SAID ASSESSMENTS AND SAID WARRANTS; PROVIDING FOR THE ADVERTISEMENT OF BIDS TO CONSTRUCT SUCH IMPROVEMENTS AND FIXING A TIME AND PLACE FOR BID OPENING AND ALL OTHER THINGS REQUIRED BY CHAPTER 16, TITLE 10, UTAH CODE ANNOTATED, 1953.

BE IT RESOLVED BY THE CITY COUNCIL OF SALINA CITY, SEVIER COUNTY, STATE OF UTAH, AS FOLLOWS:

SECTION 1: The City Council of Salina City, Sevier County,

Utah, finds and determines that there was published in the Salina Sun on June 4, 11, 18 and 25, 1981, a "Notice of Intention" to create a Special Improvement District, a copy of which Notice of Intention is attached hereto and incorporated in full in this Resolution; that a copy of said Notice was mailed by U.S. Mail, postage prepaid, to each owner of land to be assessed within the proposed Southeast Improvement District (hereinafter the ("DISTRICT")) at the last known address of such owner, using for such purpose the name and address appearing on the last completed real property assessments rolls of Sevier County, Utah, and also by mailing a copy of such Notice, postage prepaid, addressed to "OWNER" at the street number or a satisfactory mailing address, where no street number was assigned, in compliance with Section 10-16-6, Utah Code Annotated, 1953, of each piece of improved property to be affected by said assessment, each of said notices having been mailed not later than ten (10) days after the first publication of such notice, fixing July 1, 1981, at 8:00 O'Clock P.M. in the Salina City Hall, as the time and place for hearing and considering any protests which were filed thereto on or before the time and date fixed in said notice.
