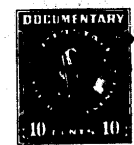

THIS INDENTURE made on the 11th day of August, 1965 by and between JAMES OREN JENSEN, as the duly appointed, qualified and acting Executor of the Last Will and Testament of Georgine B. Jensen, also known as Georgine B. Gundersen Jensen, also known as Georgine Jensen and as Georginie B. Jensen, Deceased, late of Salt Lake County, State of Utah, Party of the First Part, and DON L. BUEHNER and ALICE W. BUEHNER, his wife, as joint tenants and not as tenants in common with full rights of survivorship, Parties of the Second Part,

WITNESSETH:

THAT, whereas, on or about the 7th day of July, 1965, the District Court of the Third Judicial District, in and for Salt Lake County, State of Utah, Probate Division, made and entered its Order confirming and approving sale of the real property herein-after described to the Parties of the Second Part, and authorizing and directing the Party of the First Part, as the Executor of the Last Will and Testament of Georgine B. Jensen, etc., Deceased, as aforesaid, to make, execute and deliver to said Parties of the Second Part, the Executor's Deed of the Party of the First Part conveying to the Parties of the Second Part the said real property, subject of said sale, the same being more particularly hereinafter described, and which said Order of the Court is now on file and of record in the Office of the Clerk of said Court and is hereby referred to and made a part of this Indenture.

NOW, THEREFORE, the said JAMES OREN JENSEN, the Executor of the Last Will and Testament of Georgine B. Jensen, also known as

Georgine B. Gundersen Jensen, also known as Georgine Jensen and as Georginie B. Jensen, Deceased, the Party of the First Part, pursuant to the Order of the Court as aforesaid, and for and in consideration of the sum of Sixteen Thousand Seven Hundred Fifty and No/100 Dollars (\$16,750.00) in lawful money of the United States of America to him in hand paid by the Parties of the Second Part, the receipt whereof Executor hereby acknowledges, has granted, bargained, sold and conveyed, and by these presents does hereby grant, bargain, sell and convey unto the said DON L. BUEHNER and ALICE W. BUEHNER, his wife, as joint tenants and not as tenants in common with full rights of survivorship, all the right, title, interest and estate of the Party of the First Part, as the duly appointed, qualified and acting Executor of the Last Will and Testament of Georgine B. Jensen, also known as Georgine B. Gundersen Jensen, also known as Georgine Jensen and as Georginie B. Jensen, Deceased, together with all the right, title and interest which the Estate of said Decedent by operation of law or otherwise may hereafter acquire in and to all that certain real property situate in Salt Lake County, State of Utah, (at the address commonly known as 2602 East 6200 South, Salt Lake City, Utah,) and more particularly described as follows, to-wit:

Commencing at a point in the center of a public road commonly known as 6200 South Street 672 feet West from the Northeast corner of Section 22, Township 2 South, Range 1 East, Salt Lake Base and Meridian and running thence South 339 feet; thence South 73 degrees 50 minutes East 104.12 feet; thence South 175 feet; thence West  $12\frac{1}{2}$  feet; thence North 152.58 feet; thence North 73 degrees 50 minutes West 80.48 feet; thence West 196.2 feet; thence North 368 feet to the center of said public road; thence East along the center of said public road 186 feet to the place of beginning. Containing 1.6 acres more or less.
