RESOLUTION ANNEXING A CERTAIN AREA HEREIN DESCRIBED TO SALT LAKE COUNTY COTTONWOOD SUBURBAN SANITARY DISTRICT WITHIN SALT LAKE COUNTY, UTAH.

WHEREAS, Salt Lake County Cottonwood Suburban Sanitary District has installed sewer facilities and now is serving county residents in an area of the unincorporated sections of Salt Lake County; and

WHEREAS, continued growth of population in Salt Lake County has increased the need for sewer facilities and sewer service to residents within an area adjacent to the Salt Lake County Cottonwood Suburban Sanitary District, hereinafter referred to as The District, and said District presently is providing such facilities and service to a portion of said area; and

WHEREAS, both the Board of Trustees of said District and residents of said area have requested annexation to said District; and

WHEREAS, the public health, convenience and necessity require annexation of said area described herein in order to prepare for the growth and development of the unincorporated areas of Salt Lake County;

WHEREAS, the Board of County Commissioners of Salt Lake County by Resolution adopted the 29th day of September, 1961, determined that the public health convenience and necessity required the annexation of said area and gave notice of intention to annex said area to the sid District, which notice called for a public hearing at 10:00 A. M. on Wednesday, November 3rd, 1965, at the office of the Board, 206 City & County Building, Salt Lake City, Utah which notice has been duly and legally published as provided in the statutes of the State of Utah; and

WHEREAS, public hearing was held pursuant to said Resolution and Notice at the time and place aforesaid, at which meeting all parties were heard either in support of or in opposition to annexation of the said area to the said District, no one appearing in opposition thereto and no written protest having been filed by anyone within any area proposed to be annexed to the said District; and

WHEREAS, all of the testimony presented at the public hearing supported annexation of the said area to the said District by showing that all of said area and all of the property owners in said area would be benefited by the improvements installed and to be installed for sewerage disposal purposes;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of County Commissioners of Salt Lake County, State of Utah, that the following described area, bounded as hereinafter set forth, shall be and the same hereby is annexed and made a part of Salt Lake County Cotton-wood Suburban Sanitary District, and that the boundary lines of Salt Lake County Cottonwood Suburban Sanitary District be modified to include said area. The area and boundaries thereof hereby annexed to Salt Lake County Cottonwood Suburban Sanitary District is as follows:

AREA "A"

Beginning at a point on the boundary of the Salt Lake County Cottonwood Sanitary District 200 Feet North of the North line of 7000 South Street which point is South 1000 Feet more or less from the Northeast Corner of Section 26, Township 2 South, Range 1 East, Salt Lake Base and Meridian. Running thence parallel to and 200 feet North of the North line of 7000 South Street, Easterly to the East line of Section 25, Township 2 South, Range 1 East, Salt Lake Base and Meridian; thence South 1000 feet, more or less to the East Quarter Corner of said Section 25; thence West 2640 feet, more or less, to the Center of said Section 25; thence South 2640 feet, more or less, to the South Quarter Corner of said Section 25; thence East 2640 feet, more or less to the Southeast Corner of said Section 25; thence South 5280 feet, more or less, to the Southeast Corner of Section 36, Township 2 South, Range 1 East, Salt Lake Base and Meridian; thence West 2640 feet, more of less, to the South Quarter Corner of said Section 36; thence South 5280 feet, more or less, to the South Quarter Corner of Section 1, Township 3 South, Range 1 East, Salt Lake Base and Meridian; thence East 2640 feet, more or less, to the Southeast Corner of said Section 1; thence South 5280 feet, more or less, to the Southeast Corner of Section 12, Township 3 South, Range 1 East, Salt Lake Base and Meridian; thence West along the South section line of Sections 12, 11 and 10 to a point 1320 feet East of the Southwest Corner of Section 10, Township 3 South, Range 1 East, Salt Lake Base and Meridian and the boundary of the Salt Lake County Cottonwood Sanitary District; thence along the boundary of the Salt Lake County Cottonwood Sanitary District; North 5280 feet, more

Thence East along a line 660 feet North of and parallel to the South boundary line of Sections 35 and 36 to a point 200 feet West of West Temple Street; thence South along a line 200 feet West of and parallel to said West Temple Street to a point 200 feet South of 4070 South Street extended West; thence East along a line 200 feet South of 4070 South Street to a point 400 feet East of State Street; thence Southeasterly 650 feet to a point 700 feet East of State Street and 500 feet North of Gordon Lane; thence East 270.0 feet; thence South 200 feet; thence East 200 feet to a point 200 feet West of 300 East Street extended to the South; thence Southeasterly to a point 20 feet East of point where Cottonwood Sanitary District Outfall line enters Gordon Lane from the South; thence Southeasterly 20 feet East of and parallel to said outfall line to the centerline of Big Cottonwood Creek; thence Northwesterly along the centerline of Big Cottonwood Creek to the Murray City Boundary line; thence along the Murray City boundary line North 27°29'34" East 617.08 feet to the South line of Gordon Lane; thence along the Murray City boundary line (North 50°27'45" West 382.39 feet; thence North 46°16' West 215.8 feet; thence North 35°07' West 208.4 feet; thence South 59°04' West 82.52 feet; thence North 50°00'33" West 126.70 feet; thence South 68°55'05" West 49.07 feet; thence South 52°29'17" West 43.30 feet; thence North 86.56' West 32.92 feet; thence North 66°33'02" West 27.69 feet; thence North 46°43'53" West 27.59 feet; thence North 88°49'30" West 313.07 feet; thence South 0°10'02" West 566.19 feet; thence West 7100 feet more or less) to the center line of the Jordan River; thence Northwesterly along the center line of the Jordan River to the point of beginning.
