The right of way to include a strip of ground 20 ft wide. The said pipe line will run parallel to the Cottonwood District Sewer pipe, at a distance of 26 ft W at pt of entry into property on North side, 20 ft W at Manholes, and 18.8 ft W at the South property line. The 8 inch outflow line to connect on to the Main Sewer line at a pt West of Barn, and extend in an Easterly direction approx. 12 ft S fr the S W cor of Barn, Est'ly between clump of willow trees and hay shed to a pt 6 ft N fr N E Cor of hay shed.

The rights hereby granted are subject to the condition that Grantee shall compensate Grantor at a reasonable appraised valuation for any damages done to Grantor's land or crops caused by Grantee in the construction, maintenance repair and operation or replacement of said pipe line.
