RIGHT OF WAY AGREEMENT FOR

Geo. A. Howard and Ethel LaBeryl Howard, his wife,  
of Salt Lake Co., State of Utah, Grantors, do hereby convey and warrant  
to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing  
under and by virtue of the laws of the State of Utah, Grantee, for the sum of Fifty Dollars

DOLLARS (\$ 50.00 ) receipt of which is hereby  
acknowledged, a right of way and easement for the purpose of digging a trench along said right  
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through  
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:  
Com 320 ft S & S 52°30' W 66 ft fr NE cor of NW 1/4 sec 10, T 2S, R 1E, S.L.M.  
S 52°30' W 209 ft; N 46°25' W 160 ft; N 52°30' E 230 ft m or l; S 47°25' E 160  
ft; to beg. Also com 320 ft S & S 52°30' W 66 ft; N 47°25' W 240 ft; fr NE cor  
sd NW 1/4 sec 10, ; S 52°30' W 240 ft m or l; N 46°25' W 137.5 ft; N 65° E 40 ft;  
N 20°15' W 186.8 ft; N 65° E 152 ft; S 47°25' E 277.7 ft to beg. Also com 136.6  
ft W & S 52°30' E 345.8 ft & S 52°30' W 246 ft; N 47°25' W 517.7 ft fr NW cor sec  
10, T 2S, R 1E, S.L.M. N 65° E 60 ft; S 47°25' E 362 ft; S 65° W 60 ft; N 47°25'  
W 60 ft; N 47°25' W 392 ft to beg.  
the center line of said pipe shall extend through and across the above land and premises on a line  
described approximately as follows: beg at a pt on the N prop line approx'ly 101 ft  
E of the W prop line sd pt starting at a MH, in 4800 S st, th deflect 65°22'  
(sd deflection taken fr E of MH) th in a southerly direction 300 ft to a  
MH, th deflect left 5°55' to a pt on the S prop line approx'ly 175 ft E of  
the W prop line

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so  
long as such pipe line shall be maintained, with the right of ingress and egress to and from said  
right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor  
to fully use the said premises except for the purposes for which this right of way or easement is  
granted to the said Grantee.

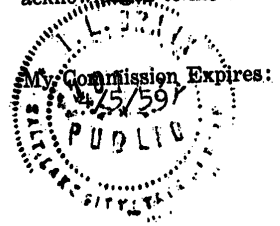
The rights hereby granted are subject to the condition that Grantee shall compensate Grantor  
at a reasonable appraised valuation for any damages done to Grantor's land or crops caused by Grantee  
in the construction, maintenance, repair and operation or replacement of said pipe line.
