~~FOR THE PURPOSES OF CONVEYING TO THE GRANTEE A RIGHT-OF-WAY, AND TO LAY, MAINTAIN, OPERATE, REPAIR, REMOVE, OR REPLACE THE PIPE LINE FOR TRANSPORTATION THROUGH AND ACROSS THE GRANTOR'S LAND AND PREMISES IN SALT LAKE COUNTY, STATE OF UTAH, AND LOCATED IN:~~

Com on E side of City Cannal 74.03 rds N & 66.4 rds E fr S W cor Sec 10, T2S, R1E, S L Mer. S 100 ft; S 55°E 200 ft; N 4°59' W 373.5 ft; M or L to E Boundry of sd cannal. S 39° 53' W 280 ft. M or L to beg.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:

Com at a point on the South Property line, approx. 36 ft West of the S E Cor of the above property, thence South Easterly direction 36 ft along the roadway, to the S E Cor of said property, Cen of road.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District, so long as such pipe line shall be maintained with the right of ingress and egress to and from said right-of-way, and to maintain, operate, repair, remove or replace the same. The said Grantor to fully use the said premises except for the purposes for which this right-of-way or easement is granted to the said Grantee.

The rights hereby granted are subject to the condition that Grantee shall compensate Grantor at a reasonable appraised valuation for any damages done to Grantor's land or crops caused by Grantee in the construction, maintenance repair and operation or replacement of said pipe line.

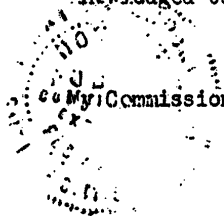
