CONSENT TO PERPETUAL EASEMENT

SALT LAKE CITY, a municipal corporation of the State of Utah, GRANTOR, hereby grants to the STATE ROAD COMMISSION OF UTAH, GRANTEE, a perpetual easement for highway right of way across and upon the hereinafter described real property for the purpose of and subject to the conditions hereinafter set forth.

The lands hereinafter described are presently being used by Salt Lake City Corporation for reservoir and conduit installations and any and all use by the said State Road Commission shall be subject to the City's use of said lands.

The lands which the City by this Consent to Perpetual Easement allows the State Road Commission to use are located in the County of Salt Lake, State of Utah, and more particularly described as follows:

Beginning on the easterly boundary line of said entire tract of property at a point 1711.48 ft. east, 63,37 ft. north, 854.30 ft. S. 89°59°54" E. and 253.29 ft. N. 19° 34' W. from the City Monument at the intersection of 13th East Street and 5th South Street, said point of beginning is also 50.0 ft. perpendicularly distant easterly from the center line of Guardsman Way at Engineer Station 8 ± 64.72 ; thence N. $19^{\circ}34^{\circ}$ W. 105.49ft. along said easterly boundary line to a point 50.0 ft. radially distant southerly from the center line of said highway project; thence Westerly 35.89 ft. along the arc of a 6027.07 ft. radius curve to the right to a point 50.0 ft. perpendicularly distant westerly from the center line of said Guardsman Way (Note: Tangent to said curve at its point of beginning bears N. 73°00'35" W.); thence S. $17^{\circ}50^{\circ}52^{\circ}$ W. 224.13 **f**t. to a point of tangency with a 622.96 ft. radius curve to the left; thence Southerly 138.52 ft. along the arc of said curve to the south boundary line of said entire tract of property; thence S. 89°59'54" E. 100.43 ft. along said south boundary line to a point 50.0 ft. radially distant easterly from the center line of Guardsman Way; thence Northerly 107.75 ft. along the arc of a 522.96 ft. radius curve to the right to a point 50.0 ft. perpendicularly distant easterly from the center line of Guardsman Way at Engineer Station 7+23.0 (Note: Tangent to said curve at its point of beginning bears N. $6^{\circ}02^{\circ}25^{\circ}$ E.); thence N. $17^{\circ}50^{\circ}52^{\circ}$ E. 140.82 ft. to the point of beginning as shown on the official map of said project on file in the office of the State Road Commission of Utah; said parcel of land contains 0.73 acre, more or less.

By accepting the use of said described property, the State Road Commission agrees that the use of said land shall be restricted to construction and maintenance of a temporary roadway to the University of Utah Campus from 5th South Street in the vicinity of Guardsman Way; and that in the construction, operation, and maintenance of the temporary roadway, the State Road Commission and all other parties who may be involved in said operation will protect the City's conduit which crosses through the above described property in a manner satisfactory to the City Engineer and the Department of Water Supply and Waterworks of said City.

It is further understood and agreed between the parties hereto that the use of the herein described property be, and the same
hereby is during the time of use as herein above described, subject
to the City's use of the land for future reservoir construction and
that any additional expense which may thereby be incurred by the
City, which it would not incur except for the use of said premises
by the Grantee, shall be paid for and assumed by the said Grantee.

It is further understood and agreed between the parties hereto that the use by the Grantee of the hereinbefore described lands
shall cease and determine at such time that the State Road Commission
has completed the overpass on 5th South near Guardsman Way and upon
such competion the State Road Commission agrees to leave the said
premises in the same condition as they were prior to the herein
granted use.
