 SALT LAKE CITY SUBURBAN SANITARY DISTRICT NO. 1 PIPE LINE

 We, the above property owners in Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, a right of way, and to lay, Maintain, operate, repair, remove or replace the pipe line for transporation through and across the Grantors land in Salt Lake County, State of Utah, and designated as a privately owned right of way, known as 5290 South Street, and located in: SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 10, T2S, R1E, S L Mer.

The sewer line shall exted through and across the above land and premises on a line described approximately as follows: Com at a point on the East line of Highland drive and privately owned right of way known as 5290 south street, thence running in an easterly direction along said right of way 1135 ft M or L to a point approximately seven with the S E Corner of Edwin A. and Eileen B. Meadows property at 2089 East 5290 South street.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors to fully use the said land except for the purpose for which this right of way or easement is granted.
