to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existingunder and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other
consideration _____ DOLLARS (\$ 1.00) receipt of which is herebyacknowledged, a right of way and easement for the purpose of digging a trench along said right
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:
Com 957 ft. E fr S W Cor of Sec. 15, T2S, R1E, S L Base & Meridian. N 2° 20' E 710 ft;
E 451 ft; S 4° 15' W 557.9 ft; W 150 ft; S 4° 15' W 150 ft; W 269.5 ft to beg. 7.21 Ac.the center line of said pipe shall extend through and across the above land and premises on a line
described approximately as follows:Enters above property form 6200 South Street at a pt 66 ft West fr the S E Cor of property,
or 32 ft West fr the fence line marking the west line of private drive way, thence North
385 ft. parallel to ~~and~~ said driveway to a pt 42 ft. West fr said fence line.TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so
long as such pipe line shall be maintained, with the right of ingress and egress to and from said
right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors...
to fully use the said premises except for the purposes for which this right of way or easement is
granted to the said Grantee.The rights hereby granted are subject to the condition that Grantee shall compensate Grantor
at a reasonable appraised valuation for any damages done to Grantor's land or crops caused by Grantee
in the construction, maintenance, repair and operation or replacement of said pipe line.
