The court decrees:

Divorce

1. **Spenser Eden Betenson** is granted a divorce based on her Affidavit of Jurisdiction and Grounds. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 78B-12-102(7))

2. **Spenser Eden Betenson** and **Joseph Nathaniel Betenson** do not have any children together.

- They do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- They are not expecting a child.
- They do not have incapacitated adult children together who are eligible for child support, or, they are not asking for child support for any adult child who is eligible for child support.

Spenser Eden Betenson will receive a share of the equity existing in the property on the date the divorce decree is signed.

- The total equity to be divided is **\$78,242.73**.
- **Spenser Eden Betenson's** share is **\$77,368.05**.
- **Spenser Eden Betenson** will have an equitable lien against the property in the amount of **\$77,368.05**. **Spenser Eden Betenson** will sign a quitclaim deed to **Joseph Nathaniel Betenson** subject to that lien once the divorce is entered.
- **Joseph Nathaniel Betenson** will pay **Spenser Eden Betenson** **\$77,368.05** to satisfy the lien. Once **Joseph Nathaniel Betenson** has paid the lien, **Spenser Eden Betenson** will sign any documents necessary to remove the lien from the property.

Alimony

8. Neither party will pay alimony.

Retirement money

9. The parties do not need a court order about retirement money.

Duty to sign documents

10. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

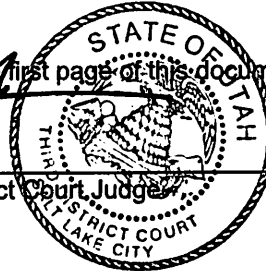
