

Farming Easement

**PARCEL A**

BEGINNING AT A POINT IN THE EXTENSION OF A FENCE LINE, WHICH POINT IS NORTH 89°17'19" EAST ALONG THE SECTION LINE 226.17 FEET AND SOUTH 513.01 FEET (BASED ON THE UTAH STATE COORDINATE SYSTEM, CENTRAL ZONE AND DATA PUBLISHED BY THE UTAH COUNTY SURVEYOR AS OF JANUARY 1986) FROM THE NORTH QUARTER CORNER OF SECTION 10, TOWNSHIP 7 SOUTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN; THENCE SOUTH 01°09'01" EAST, SALT LAKE BASE AND MERIDIAN; THENCE SOUTH 01°09'01" WEST ALONG SAID FENCE LINE AND EXTENSION THEREOF 239.46 FEET, TO A FENCE CORNER; THENCE NORTH 89°11'47" WEST ALONG THE EXTENSION OF A FENCE LINE 64.65 FEET; THENCE SOUTH 01°04'40" WEST 136.30 FEET; THENCE NORTH 88°55'20" WEST 495.72 FEET; THENCE NORTH 01°04'40" EAST 408.30 FEET; THENCE SOUTH 89°00'00" EAST 235.57 FEET; THENCE SOUTH 01°00'00" EAST 16.50 FEET; THENCE SOUTH 89°00'00" EAST 144.80 FEET; THENCE SOUTH 01°00'00" WEST 16.50 FEET; THENCE SOUTH 89°00'00" EAST 179.68 FEET TO THE POINT OF BEGINNING.
