A five foot easement, the South line of which is as follows:

Commencing 60 rods South from the northeast corner, Section 31, Township 1 South, Range 1 West, Salt Lake Base and Meridian; thence West 80 rods.

County of Salt Lake, and State of Utah and upon and along the roads, streets, alleys or highways adjoining the said property, with the right to permit the attachment of the wires and fixtures of any other company, the right to trim any brush and trees so as to keep such brush and trees cleared at least four feet from all wires, and the right to set the necessary guy and brace poles and anchors, and to attach thereto necessary guy wires.


