# Quit Claim Deed

Parcel No. 02-3:49H  
Project No. 1-80-3(5)116

SALT LAKE COUNTY, Grantor,  
 of Salt Lake City, Salt Lake County, State of Utah  
 hereby convey and warrant to the Western Pacific Railroad Co., Grantee, for  
 the sum of One thousand seven hundred fifty & 00/100----- Dollars,  
 the following described parcel of land in Salt Lake County, State of Utah,  
 to-wit:

A parcel of land in fee for a railroad track relocation incident to the  
 construction of a freeway known as Project No. 80-3, being part of an entire  
 tract of property in Lot 32, Block 5, Miles and Hamiltons Add., Salt Lake City  
 Survey.

The boundaries of said parcel of land are described as follows:

Beginning at the SW. corner of said Lot 32; thence North 43 ft., more or  
 less, along the west line of said Lot 32 to a point 45 ft. perpendicularly  
 distant northwesterly from the center line of the Western Pacific Railroad  
 Track Relocation for said project; thence N. 65°18'21" E. 152 ft., more or  
 less, to the north line of said Lot 32; thence East 5 ft., more or less, to  
 the NE. corner of said Lot 32; thence South 41 ft., more or less, to the SE.  
 corner of said Lot 32; thence Southwesterly 156 ft., more or less, along the  
 southeasterly line of said Lot 32 to the point of beginning, less and excepting  
 that portion of land lying within the existing Union Pacific Railroad Company  
 Right of Way. The above described parcel of land contains 0.111 acre, more or  
 less.
