SHARED ACCESS AGREEMENT:

THE PROPERTY OWNERS HAVE AGREED WITH UDOT TO LIMIT ACCESS TO PARCELS LAND 2 TO A DRIVEWAY ALONG THE NORTH BOUNDARY OF PARCEL 1 AND ONE DRIVEWAY ALONG THE EAST BOUNDARY OF PARCEL 2. TO AID TO THE FUTURE DEVELOPMENT OF THE PROPERTY PRESENTLY KNOWN AS 2133 NORTH 2000 WEST, THE OWNERS OF PARCELS 1 AND 2 DO HEREBY GRANT TO EACH OTHER, THEIR HEIRS AND ASSIGNS, THE RIGHT OF ACCESS ACROSS THEIR PROPERTIES, AND AGREE TO MAINTAIN SAID PROPERTIES WITH DRIVEWAYS AND PARKING AREAS IN A MANNER WHICH WILL NOT IMPEDE SAID ACCESS.

NOTES:

MANY AREAS IN CLINTON CITY HAVE WATER PROBLEMS DUE TO A SEASONALLY HIGH (FLUCTUATING) WATER TABLE. APPROVAL OF THIS PLAT DOES NOT CONSTITUTE REPRESENTATION BY THE CITY THAT ANY BUILDING AT ANY SPECIFIED ELEVATION WILL SOLVE GROUND WATER PROBLEMS. SOLUTION OF THESE PROBLEMS IS THE SOLE RESPONSIBILITY OF THE PERMIT APPLICANT AND PROPERTY OWNER.

ALL EASEMENTS ON LOT 32 OF SNOWBERRY SUBDIVISION PHASE 1 ARE VACATED UPON RECORDATION OF THIS PLAT.

Boundary Description

PART OF THE NORTHEAST QUARTER OF SECTION 28, T.5N., R.2W., S.L.B.&M., U.S. SURVEY. DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF LOT 14, SNOWBERRY SUBDIVISION PHASE 1, AND THENCE S89°43'37"E 100.79 FEET, THENCE S89°59'55"E 74.95 FEET, TO A POINT ON A 25.00 FOOT RADIUS CURVE THE CENTER OF WHICH BEARS S00°00'05"W, THENCE SOUTHEASTERLY ALONG SAID CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 90°09'24" A DISTANCE OF 34.32 FEET, THENCE S00°07'29"W 304.88 FEET, THENCE N89°59'25"W 200.00 FEET, THENCE N00°00'05"E 333.90 FEET TO THE POINT OF BEGINNING.

Basis of Bearings

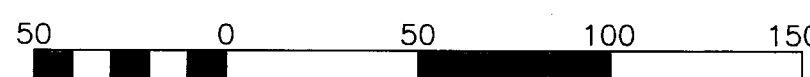
BASIS OF BEARING IS AS PER RECORDED SUBDIVISION PLAT OF SNOWBERRY SUBDIVISION PHASE 1 MONUMENTS. BEARING BETWEEN THE MONUMENT AT THE INTERSECTION OF 2700 WEST STREET AND 2200 NORTH STREET AND THE MONUMENT AT THE INTERSECTION OF 2000 WEST STREET AND 2200 NORTH STREET IS S89°59'55"E (BASIS OF BEARINGS).

Narrative

THE PURPOSE OF THIS PLAT IS TO SUBDIVIDE LOT 32 OF SNOWBERRY SUBDIVISION PHASE 1 INTO TWO PARCELS. ALL CORNERS WERE SET WITH A 3/8" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES". ALL FRONTS WERE SET WITH LEAD PLUG AND TACK IN THE TOP BACK OF CURB AT THE EXTENSION OF THE SIDE LOT LINES.

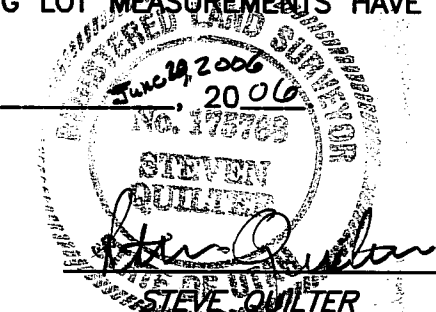
