Grantor, of CLINTON, County of DAVIS, State of UTAH, hereby GRANTS AND CONVEYS to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum of TEN Dollars,

Two perpetual easements upon part of an entire tract of land, situated in the Northeast quarter of Section 28, Township 5 North, Range 2 West, Salt Lake Base and Meridian for the purpose of construction improvements including cut and/or fill slopes and appurtenant parts thereof for the widening and grading of the existing highway SR-108 known as 2000 West Street, known as Project No. STP-0108(11)8, and said entire tract of property recorded as Entry 2043906, Book 3702, Page 26 at the Davis County Recorder's office, said portion being described more particularly as follows:

Beginning at a point which is South 00°07'29" West 1,188.39 feet along the section line and North 89°52'31" West 39.02 feet from the Northeast corner of said Section 28; thence South 00°07'29" West 133.00 feet to the grantor's south boundary line; thence North 89°52'31" West 12.00 feet (*WEST by record*) along said south boundary line; thence North 00°07'29" East 133.00 feet to the grantor's north boundary line; thence South 89°52'31" East 12.00 feet (*EAST by record*) along said north boundary line to the point of beginning.
