RIGHT OF WAY AGREEMENT FOR  
SALT LAKE CITY SUBURBAN SANITARY DISTRICT PIPE LINE

of Salt Lake County \_\_\_\_\_, State of Utah, Grantors, do hereby convey and warrant  
to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing  
under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other  
consideration DOLLARS (\$ 1.00 ) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right  
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through  
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:  
Com 1070 ft N & 2622 ft E & N 69° E 533.5 ft fr S 1/4 Cor Sec 3, T2S, R1E. N 69° E 117.7 ft;  
S 21° E 110 ft; S 69° W 117.7 ft; N 21° W 110 ft. to beg. being in the S W 1/4 Sec 2, T2S, R1E,  
S L Mer. Also Com at the N W Cor of Lot 1, Spring Creek Subdivision, S 69° W 217 ft;  
S 21° E 90 ft; N 69° E 115 ft; N 27° 54' 140" E 136.02 ft to beg. 0.41 ac. being in the S W  
1/4 Sec 2, T2S, R1E, S L Mer.

the center line of said pipe shall extend through and across the above land and premises on a line  
described approximately as follows:  
Com at existing Manhole # 9x00 in dead end of Spring Creek road, (approx. 2775 E 4600 So)  
and running thence South Easterly direction 100 ft. M or L to cen of proposed street,  
known as 2770 East St, which is to be extended. Right of way to include 5 ft. each side  
of center line. of pipe.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so  
long as such pipe line shall be maintained, with the right of ingress and egress to and from said  
right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors  
to fully use the said premises except for the purposes for which this right of way or easement is  
granted to the said Grantee.

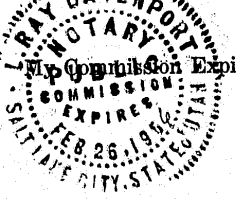
~~The rights hereby granted are subject to the condition that Grantors shall compensate Grantee
