

RIGHT-OF-WAY AND MAINTENANCE GRANT  
JUAB SCHOOL DISTRICT, a political subdivision of the State of Utah, Wyoming &  
LYNN, GAYLOR W. LYNN, DIXON M. LYNN, MARSHAN W. LYNN, as individuals, and  
DEVON C. WINN and LAUREN L. WINN, as Co-Trustees of the DEVON C. LYNN TRUST  
hereby dated June 8, 1993, as amended, hereinafter referred to as Grantors, by NANCY  
CRUTCH, a natural corporation, hereinafter referred to as Grantee, the receipt of which is  
hereby acknowledged, the Grantors do hereby grant, and convey unto the Grantee, its successors  
and assigns, a perpetual easement with the right to construct and lay and thereafter use, operate,  
inspect, repair, maintain, replace, and remove power lines and appurtenances through the land  
of the Grantors situated in Juab County, State of Utah, said land being described as follows:

The Easement shall be 50 feet in width during construction, and upon  
completion the perpetual easement shall be 20 feet in width, 10 feet on each  
side of the centerline of Grantee's pipeline, more particularly described as  
follows, to-wit:

Beginning at the Masonite Building at a point which is South 0°08'01" West 246.07 feet along the Section Line and West 242.39 feet to the Northwest corner of Lot B, Block "C" of the Lynnwood Subdivision and South 0°01'43" West 382.42 feet along the North line of Block "C" of the Lynnwood Subdivision to a point which is South 0°01'46" West 10.00 feet from the centerline of 800 Main Street from the East Quarter Corner of Section 33, Township 12 South, Range 1 East, Salt Lake Base and Meridian, thence North 1°04'49" West 800.00 feet, thence North 48°23'21" West 513.66 feet, thence North 48°20'33" West 200.37 feet to a point which is 30.00 feet North of the 1/16 line, thence South 0°42'07" West 1433.10 feet, thence South 0°39'00" feet to an existing manhole, thence South 0°42'07" West 128.00 feet to the East right-of-way of 400 Main Street, Pocatello.

TO HAVE AND TO HOLD the same unto the Grantee, its successors and assigns, with  
the right of access through such property along this right-of-way to build, maintain, operate,  
repair, inspect, protect, remove, and replace the same. In the case of an emergency where it  
would be hazardous to do otherwise, access may be from surrounding property. The Grantors  
shall have the right to use the said premises except for the purpose for which this right-of-way  
and easement is granted to the Grantee provided such use does not interfere with the maintenance  
or any other rights granted to the Grantee hereunder.

The Grantors shall not build or construct nor permit to be built or constructed any  
permanent structure over said right-of-way. The Grantors shall not build or permit to be built  
any other improvement or pipe over, across, or under said right-of-way, or lower the contour  
thereof without notifying the Grantee at least two working days before any digging begins.

It is hereby understood that any parties requiring this grant on behalf of the Grantee are  
without authority to make any representations, covenants, or agreements not herein expressed.
