AND CONVEYS to ROY CITY CORPORATION, at 5051 South 1900 West, Roy City, Utah  
84067, Grantee, for the sum of \_\_\_\_\_ and other good and valuable  
consideration.

A perpetual slope easement upon part of an entire tract of property situated in the Southwest Quarter of Section 11, Township 5 North, Range 2 West, Salt Lake Base & Meridian, U.S. Survey for the purpose of constructing thereon a retaining wall, cut and/or fill slopes and appurtenant parts thereof incident to the widening and grading of the existing 4800 South Street, known as Project No. STP-3308(1)3. The boundaries of an entire tract are described as follows:

Beginning at a point on the northerly Right-Of-Way Line of 4800 South Street, which is South 89°41'25" East 687.97 feet along the South Line of said Section 11 and North 00°18'35" East 33.00 feet from the Southwest Corner of said Section 11, said point also being opposite Engineers Station 16+87.97; running thence the following (3) courses and distances; (1) North 00°18'35" East 6.00 feet; (2) South 89°41'25" East 79.51 feet; (3) South 00°13'00" West 6.00 feet to the northerly Right-Of-Way Line of 4800 South Street; thence North 89°41'25" West 79.52 feet along said Right-Of-Way Line to the Point of Beginning.

The above described part of an entire tract contains 477 square feet in area or 0.01 acres, more or less.
