of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other consideration DOLLARS (\$ 1.00 ) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in: Com on W'ly line of Wallace Lane 888.96 ft N & 512 ft M or L W fr S 1/4 Cor Sec 2, T2S, R1E, S L Mer. W 200 ft; S 75°43' W 92.2 ft; S 73°55' W 200 ft M or L to Board of Education tract; S 21°02' E 178.22 ft; N 66°17'30" E 211.78; N 86°35' E 131.53 ft; E 83.74 ft; S 3°40' E 6.01 ft; W 83.74 ft; S 1°12' E 66 ft; S 89°50' E 75 ft M or L to Pt S'ly fr beg; N'ly 245 ft M or L to beg. 1.93 Ac.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows: Com at a point approximately 20 ft east and 8 ft. north from the south west corner of the above property and running thence easterly direction 120 ft M or L to irrigation ditch.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor.s to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.
