of Salt Lake City, Utah, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other consideration DOLLARS (\$ 1.00) receipt of which is hereby acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in: Vancott Addition. A Subdivision within the N W  $\frac{1}{4}$  of the N W  $\frac{1}{4}$  of Section 23, T2S, R1E, Salt Lake Base & Meridian.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows: Within the following easement.

Com at the North West Cor of Lot 4 Vancott Addition, and running thence S  $89^{\circ}45'30''$  E 184.53 ft. thence South 15 ft., thence N  $89^{\circ}45'30''$  W 186 ft M or L, thence North 15 ft. to beginning.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.
