MEMORANDUM OF LEASE Ref.

THIS MEMORANDUM OF LEASE, made this \_\_\_\_\_ day of \_\_\_\_\_, 1968, by and between TEMPLE GRANITE QUARRIES, a corporation, hereinafter called "Landlord", and PERPETUAL STORAGE, INC., hereinafter called "Tenant";

W I T N E S S E T H:

Landlord does hereby lease, demise and let unto Tenant those certain premises (hereinafter called the "demised premises") and by this reference incorporated herein, and located substantially as shown on Exhibit B attached hereto and by this reference incorporated herein;

TO HAVE AND TO HOLD together with appurtenances for a term commencing January 1, 1968, and ending December 31, 2066, that is to say a term of ninety-nine (99) years, and the Tenant shall have four (4) successive options to extend the term of this Lease from the date upon which it would otherwise expire upon the same terms, covenants and conditions as those herein specified for four (4) separate additional periods of ninety-nine (99) years each, which options to extend may be exercised by giving written notice to Landlord not less than two (2) years before the beginning of the additional period for which the term hereof is to be extended by exercise of such option, all on the terms, covenants and conditions set forth in a lease agreement of even date herewith between the parties hereto, of which lease agreement this is a memorandum.

The said lease agreement provides, among other things, that under certain conditions specified therein, the Tenant shall have certain rights to purchase the demised premises or a portion thereof.

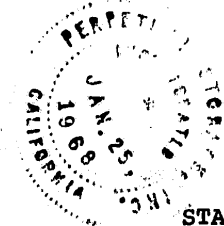

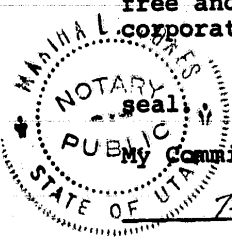

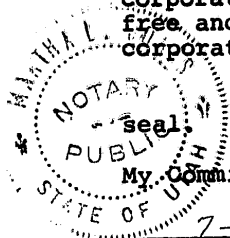
