Zip BAIDI, for the sum of Ten #10 Dollars, and other good and valuable considerations, the following described tract of land in Weber County, State of Utah, to-wit:

06-003-0011 (06-003-0010, 0012) \sqrt{r} A tract of land, situate in the SE ½ NE ½, Section 7, and the SW1/4 NW1/4, Section 8, T.5 N., R.1 W., SLB&M. The boundaries of said tract of land are described as follows:

Beginning at a point on the northwesterly right of way line of State Route 26 (Riverdale Road), said point being 510.26 feet N.01°00'35"E. along the section line and 24.84 feet West from the West Quarter Corner of said Section 8; and running thence N.51°32'44"W. 10.33 feet; thence S.47°36'27"W. 126.46 feet; thence S.38°24'20"W. 199.87 feet; thence N.36°46'57"W. 57.25 feet; thence S.45°04'13"W. 8.72 feet; thence N.36°36'17"W. 84.67 feet; thence N.46°49'23"E. 149.51 feet; thence S.43°10'37"E. 5.50 feet; thence N.46°49'23"E. 128.60 feet; thence N.75°59'23"E. 119.80 feet; thence S.06°14'23"W. 23.80 feet; thence N.75°59'23"E. 21.89 feet; thence N.85°23'57"E. 39.06 feet to said northwesterly right of way line of State Route 26; thence S.41°26'35"W. 96.41 feet along said northwesterly right of way line of State Route 26 to the point of beginning.

AIR, LIGHT, VIEW AND VISIBILITY CLAUSE:

The grantor reserves rights to use the abutting state property for highway purposes and excludes from this grant any rights to air, light, view and visibility over and across the abutting state property. The Grantee is hereby advised that due to present or future construction on the adjacent highway including but not limited to excavation, embankment, structures, poles, signs, walls, fences and all other activities related to highway construction or which may be permitted within the Highway Right of Way that air, light, view and visibility may be restricted or obstructed on the above described property.

OUTDOOR ADVERTISING:

Signs, Billboards, outdoor Advertising structures, or advertising of any kind as defined in 23 United States Code, Section 136, shall not be erected, displayed, placed or maintained upon or within this tract, EXCEPT signs to advertise the sale, hire or lease of this tract or the principal activities conducted on this land.

Together with and subject to any and all easements, rights of way and restrictions appearing of record or enforceable in law and equity.

Junkyards, as defined in 23 United States Code, Section 136, shall not be established or maintained on the above described tracts of lands.
