hereby grant and convey to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of
Three hundred and thirty-three and no/100 Dollars,

an easement upon part of an entire tract of property in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 22, T. 4 S., R. 1 W., S.L.B.&M., in Salt Lake County, Utah, for the purpose of constructing an access road and appurtenant parts thereof incident to the construction of a highway known as Project No. 0136.

Said part of an entire tract is a strip of land 40.0 ft. in width adjoining easterly the following described portion of the easterly right of way line of said project.

Beginning on an easterly boundary line of said entire tract at a point 100.0 ft. perpendicularly distant easterly from the center line of said project, said point being approximately 489 ft. east and 452 ft. north from the S $\frac{1}{4}$ corner of said Section 22; thence N. 19°36' W. 491 ft., more or less, to a point opposite Engineer Station 162+00.

The above described easement contains 0.40 acre, more or less.

After said access road is constructed on the above described part of an entire tract at the expense of said State Road Commission, said State Road Commission is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said access road and appurtenant parts thereof.
