A parcel of ground located in Sections 24 and 25, Township 2 South, Range 1 West, Salt Lake Base and Meridian, more particularly described as follows: Beginning at a point North 89°41'50" West along the section line 270.60 feet and North 0°04'42" East parallel to the East line of the Southwest 1/4, 61.38 feet from the Southeast corner of the Southwest 1/4 of said Section 24, and running thence North 89°41'50" West 69.95 feet to the East right of way line of the I-15 Freeway; thence along said East right of way line as follows: South 15°17'40" West 557.85 feet; thence South 11°49'20" West 208.51 feet; thence South 2°49' West 279.65 feet; thence South 15°40' East 159.36 feet; thence South 49°57'30" East 89.14 feet to the most Westerly corner of property deeded to Union Oil Company of California by Deed Entry No. 2228678; recorded in Book 2621, Page 159; thence leaving said East right of way line and running thence North 37°19'53" East 107.30 feet; thence South 87°13'58" East 130.00 feet; thence South 140.00 feet to the North right of way line of State Highway Project No. 0150; thence along said North right of way line as follows: South 87°13'58" East 181.79 feet to a point of a 22,871.81 foot radius curve to the left; thence Southeasterly 68.08 feet along the arc of said curve; thence North 81°30'24" East 81.02 feet; thence leaving said North right of way line and running thence North 0°20' East 1229.56 feet to the South line of said Section 24; thence North 89°41'50" West along said South line 48.03 feet; thence North 2°15' West 726.72 feet; thence North 89°41'50" West parallel to the South line of said Section 24, 207.12 feet to a point on a curve to the right on the East right of way line of the I-15 Freeway, the center of which is North 85°13'52" West 2069.86 feet; thence Southwesterly 17.52 feet along the arc of said curve and said East right of way line; thence South 10°54' West 216.36 feet along said East right of way line to a point on a curve to the right, the center of which is North 78°44'46" West 2059.86 feet; thence Southwesterly 145.26 feet along the arc of said curve and said East right of way line; thence South 15°17'40" West 36.75 feet along said East right of way line; thence leaving said East right of way line and running thence South 0°04'42" West parallel to the East line of the Southwest 1/4 of said Section 24, 257.45 feet to the point of beginning.

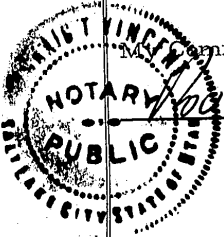
