QUIT-CLAIM EASEMENT GRANT

WHEREAS, DRAPER IRRIGATION COMPANY, a Utah nonprofit mutual water company, hereinafter called the "Grantee", has heretofore laid its culinary water lines within the right of way of those certain county roads delineated on the attached plat, Exhibit A, and more particularly described hereinafter; and

WHEREAS, Grantee desires Salt Lake County to confirm the right and entitlement of Grantee with regard to such lines insofar as the same is possible within the power of Salt Lake County;

NOW, THEREFORE, Salt Lake County hereby quit-claims unto Grantee the right and easement to occupy and use that portion of the premises of the County within the rights of way of the county roads hereinafter described, which are presently occupied by Grantee's existing water lines as the same are presently laid and placed within said roads and rights of way, together with the right to operate, maintain, replace and repair said lines, at Grantee's sole expense, for the purpose of transporting culinary water. Said roads as delineated on the attached plat, Exhibit A, are described as follows:

In the event Grantee causes damage or injury to the roadbed or surface of said roads in the course of its maintenance, replacement or repair of said lines, Grantee shall, at its own expense, repair and correct said damage or injury.
