

AN ORDINANCE AMENDING THE REDEVELOPMENT ORDINANCE (NO 83-16) HERETOFORE ADOPTED BY THE CITY OF NAPLES IN ACCORDANCE WITH STIPULATED SETTLEMENT ENTERED INTO IN CIVIL NO. 12,054, UINTAH COUNTY DISTRICT COURT

BE IT ORDAINED by the City Council of Naples, Naples, Utah as follows:

WHEREAS, a settlement by stipulation has been arrived at in that certain civil case entitled Uintah County vs. The City of Naples Redevelopment Agency and the City of Naples, a municipal corporation, wherein the Naples Redevelopment Agency and the area included therein was challenged; and,

WHEREAS, pursuant to stipulation the area included in said Redevelopment Project Plan has, by said stipulation, been reduced and redescribed.

NOW, THEREFORE, the description of the Redevelopment Project of the City of Naples is redescribed and Ordinance 83-16 Section 1 (wherein the area is described) is amended to read as follows (said description taking the place of that description in Ordinance 83-16) to-wit:

SECTION 25, T4S, R21 E, SLB&M

Beginning at the Southeast Corner of Section 15, T4S, 421E, S.L.B.&M., thence North along the West Section Line of said Section 25 - 33.0' to the North right of way line of 1500 South Street, thence West 660.0' along the said North right of way line; thence South 33.0' to the South Section Line of said Section 25; thence East 660.0' along the South Section Line of said Section 25 to the point of beginning.

SECTION 36, T4S, R21E, S.L.B.&M.

Beginning at the Northeast Corner of Section 36, T4S, R21E, S.L.B.&M.; thence South 5280' more or less to the Southeast corner of said Section 36; thence West 455.4'; thence North 3.42 chains; thence West 258'; thence N 54°20' E 68.72'; thence North 1060'; thence West 320' more or less; thence North 626.2'; thence East 310' more or less; thence North 95.18'; thence East 430' more or less; thence North 203' thence West 321.81'; thence North 390' more or less to the East-West 1/4 Section line of said Section 36; thence East 30' more or less; thence North 1320' more or less; thence West 226' more or less; thence North 660'; thence West 40 rods; thence North 660' more or less; thence East 1320' more or less to the point of beginning.

Beginning at the Northeast corner of Section 1, T5S, R21E, S.L.M.; thence South 2540' more or less; thence West 2640' more or less; thence North 35 chains; thence East 902'; thence North 55' more or less; thence East 410' more or less; thence North 5' more or less; thence East 480' more or less; thence North 276' more or less to the North line of said Section 1; thence East 880' more or less to the point of beginning.

SECTION 30, T4S, 422E, S.L.B.&M.

Beginning at the Southwest corner of Section 30, T4S, R22E, S.L.B.&M.; thence East along the South Section line of said Section 30 630.00'; thence North 53.0' more or less to the North right of way line of 1500 South Street; thence Southwesterly 630.0' more or less along the said North right of way line; thence South 33.0' along the West Section Line of said Section 30 to the point of beginning.

SECTION 31, T4S, R22E, S.L.B.&M

Beginning at the Northwest corner of Section 6, T5S, R22E, S.L.B.M; thence East 28 rods; thence South 62 rods; thence East 860' more or less; thence South 140' more or less; thence East 20 chains to the North-South 1/4 Section line of said Section 6; thence South 1020' more or less; thence S 84°W. 266'; thence S 74°30' W 100'; thence S 65° W 100'; thence S 62° W 101'; thence S 75°6' W 120'; thence S 72°53' W 214'; thence S 86°10' W 220'; thence S 50° W 48'; thence S 60° W 41' more or less; thence North 200' more or less; thence S 71° 48'46" W 332.18'; thence S 13°W 140' more or less; thence S 56°30'W 43.52'; thence S 65° W 114' to the South line of said Section 6; thence West 1410' more or less to the West 1/4 corner of said Section 6; thence North 2640' more or less to the point of beginning. Contains 356 acres more or less.

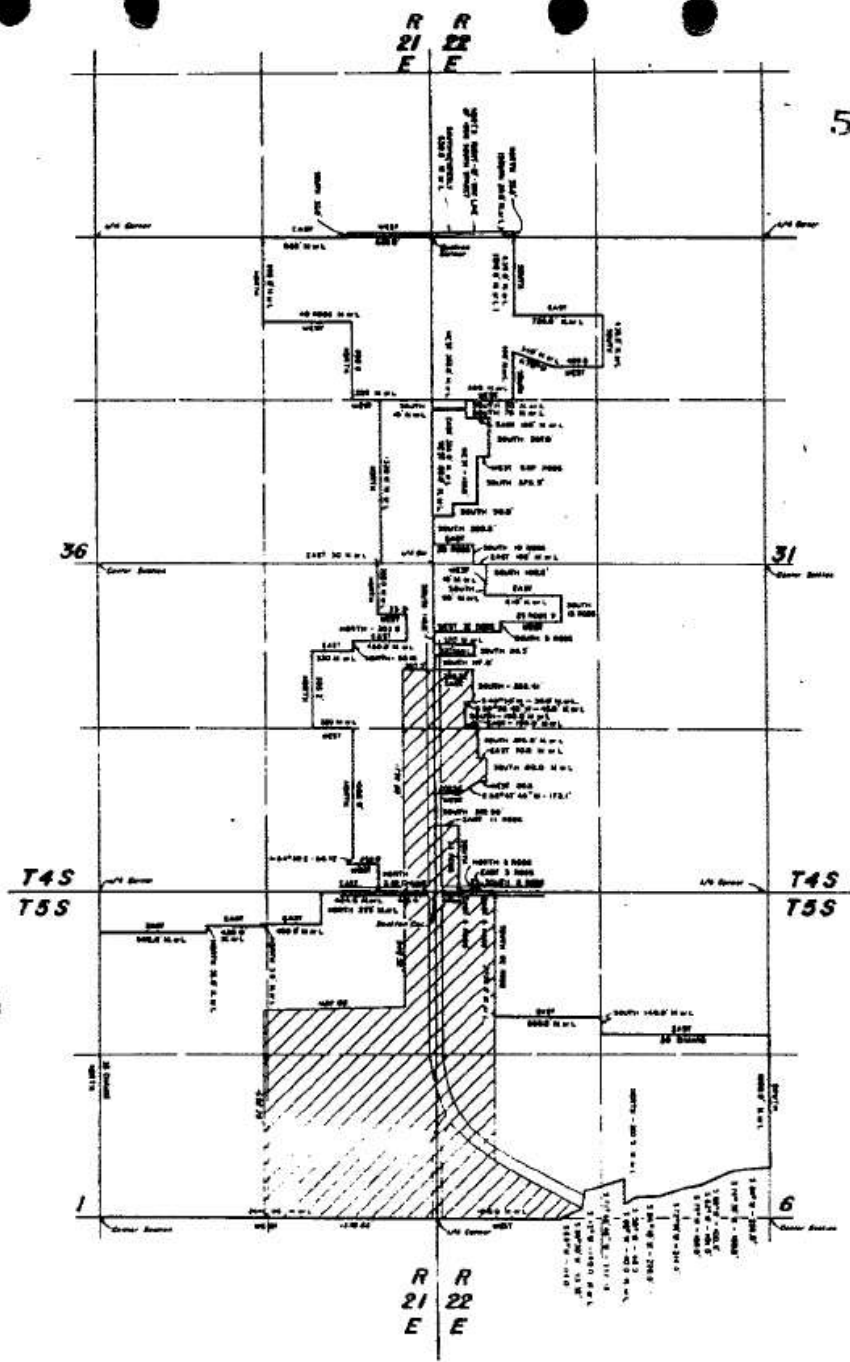
This ordinance shall become effective immediately upon publication by posting as provided by law.
